- 1. I am an attorney at law duly licensed to practice in the Central District of California. I am the appointed attorney of record for the defendant in this case.
- 2. I spent a six hours with defendant on June 29, 2009. Defendant explained that she was raised by her grandparents in the Czech Republic. Because she was an allergic child, she was unable to socialize with children her own age. The only friends she had were her grandparents' friends and books. Defendant reports that she entered University in Moscow when she was a mere 13 years of age due to her advanced intellect. She obtained her first Ph.D. when she was 17 years old. Defendant also reports that she is from an aristocratic family.
- 3. Therefore, it is my opinion that what may have appeared to be mental instability is merely eccentricity based on a completely foreign background and extremely high level of intelligence.
