17	On both August 2, 2010 [doc. 41] and August 13, 2010 [doc. 48], the Court ordered that	
18	Ronald J. McBride and Desiree Saunders comply with trial subpoenas duly issued and served	
19	upon them several months ago. The Court entered its orders after first considering each witness'	
20	frivolous Motion to Quash [docs. 14, 15] and then each witness' even more frivolous Motion to	
21	Reconsider [docs. 44, 45]. Rather than complying as ordered, each witness has filed several	
22	more frivolous pleadings [docs. 49-60], documents which are replete with the sort of anti-IRS,	
23	anti-government rants which are typical of tax defiers.	
24	Trial is set for October 5, 2010 and each day of delay further prejudices the United States'	
25	ability to adequately prepare for trial. Because these witnesses have each willfully defied the	
26	Court's orders of August 2, 2010 and August 13, 2010 and have willfully failed to comply with	
27	the subpoenas, the United States respectfully moves pursuant to Rule 17(g), Fed.R.Crim.P., and	
28	28 U.S.C. §1826(a) that Ronald J. McBride and Desiree Saunders, after hearing, be held in civil	

1	contempt and, upon their continued failure to comply, be jailed until they do comply or until the	
2	conclusion of the prosecution of Janice Sue Taylor, whichever first occurs.
