**NOTICE OF STATUS OF  
COMPLIANCE WITH TRIAL  
SUBPOENA**

16 The United States, through undersigned counsel, notifies the Court of the status of the  
17 subpoena compliance. Mr. Ronald McBride and Ms. Desiree Saunders each produced a sealed  
18 box on October 26, 2010, that allegedly contain all records responsive to the trial subpoenas. The  
19 United States agreed to leave the boxes sealed until the parties have executed act-of-production  
20 immunity agreements and declarations certifying the records to be complete and accurate.

21 Mr. McBride has provided a signed immunity agreement and a declaration certifying that  
22 the records produced on October 26, 2010, are true and correct copies of all records described  
23 in the subpoena that are in his possession, custody, or control. Mr. McBride has therefore  
24 complied with the subpoena.

25 Counsel for Ms. Saunders notified undersigned counsel that Ms. Saunders will do the  
26 same, but undersigned counsel has not yet received a copy of the immunity agreement or  
27 declaration. The United States requests that the Court wait an additional seven days before

1 purging the contempt order against Ms. Saunders. This will hopefully be enough time for Ms.  
2 Saunders to complete and return the declaration.
