The United States of America, through undersigned counsel, respectfully requests that this Court grant the government an extension to respond to Defendants' Joint Motion To Compel or Exclude Discovery (CR 44), and Defendants' Joint Motion For Bill of Particulars (CR 46) filed on December 23, 2010 respectively. The government seeks an extension until February 7, 2011.

The government seeks this extension as undersigned counsel is currently on trial before Hon. Susan R. Bolton in *United States v. Flores-Angles*, CR: 10-0506-PHX-SRB, which is scheduled to finish on January 11, 2011. Undersigned counsel will also be preparing and appearing for trial before Hon. Roslyn O. Silver on January 18, 2011 in *United States v. Jaron West*, CR: 09-1525-PHX-ROS. The government anticipates that this case will last approximately six business days.

1 On January 3, 2011, the government contacted counsels for the defendants' attorneys
2 regarding this motion. On January 4, 2011, the defendants represented that they do not oppose
3 the government's requests provided that they be permitted a three week continuance for their
4 January 31, 2011 deadline.
