(A) No new attorney has agreed to represent Exeter in this case. However, it is also anticipated that Exeter will no longer be involved in this case because Exeter recently filed a Motion to Substitute another entity to replace it as a party defendant. Exeter has transferred title to the subject real property to that entity, which effectively terminates Exeter's role in this case.
