MOTION TO DISMISS

COMPLAINANT'S SEVENTH CLAIM
ON BEHALF OF JAMES LESLIE
READING, CLARE L. READING AND
FOX GROUP TRUST
(ORAL ARGUMENT BY
TELEPHONE REQUESTED)

Now come JAMES LESLIE READING, CLARE L. READING and FOX GROUP TRUST (hereinafter collectively referred to as "Readings" or "the Readings"), through undersigned counsel, who, pursuant to Federal Rules of Civil Procedure Rule 12, move the court to dismiss Cause Seven, Action to Set Aside Transfer, of the complainant, for failure to state a cause upon which relief may be granted, in support of which the Readings offer the following:

- 1. Plaintiff's complaint sets forth its Seventh Claim at pages 9 and 10 of the complaint consisting of Paragraphs 50, 51 and 52, seeking to have a transfer from the Readings to Fox Group Trust, basing its claim on Arizona Uniform Fraudulent Transfer Act, A.R.S. 44-1001, et seq. (hereinafter "AFTA").
- 2. AFTA, at A.R.S. 44-1004-1005, provides for the setting aside of any transfer that, as therein defined, is fraudulent and made in an effort to injure creditors. That cause of action,

however, is extended only for a period of four years, after which, by virtue of A.R.S. 44-1009, the claim ceases to exist, i.e., is extinguished.

- 3. At Paragraph 14 of its complaint plaintiff contends that the transfer complained of occurred on or about June 10, 2005, and a certified copy of the quitclaim deed from the Readings to Fox Group Trust, attached hereto and made a part hereof by reference as Exhibit "A", confirms the date of the transfer as June 10, 2005.
- 4. The complaint was filed herein on April 8, 2011, and, therefore, under the terms of the AFTA, particularly A.R.S. 44-1009, any action to set aside a transfer made on or after April 8, 2007, all potential claims for nullification of any transfers occurring prior to April 8, 2007, being extinguished and no longer actionable.
- 5. Accordingly, on the basis of the allegations of the complaint, supported by Exhibit "A", the complaint fails to state a viable, actionable cause upon which relief may be granted, and, therefore, the plaintiff's Seventh Claim should be dismissed.

WHEREFORE, James Leslie Reading, Clare L. Reading and Fox Group Trust respectfully move the Court to dismiss plaintiff's Seventh Claim, with prejudice and at plaintiff's cost.


