18	The parties submit the following joint statement of the case:		
19	This is a criminal case brought by the United States government.		
20	The government charges the defendant with five counts of money laundering.		
21	Specifically, the government alleges that on five occasions Mr. Costanzo accepted money		
22	represented by undercover agents to be proceeds of drug transactions and exchanged that		
23	money for bitcoin. The government further alleges that Mr. Costanzo intended to avoid		
24	federal currency transaction reporting requirements and to conceal and disguise the nature		
25	of the money when he exchanged the money for bitcoin.

28	¹ The defendant objects to this clause. The government includes it because it is part of the disjunctive manner in which a jury may find a "sting" violation: based on the intent		

1	This is a "sting" case, which means that the money provided to Mr. Costanzo wa	
2	not actually drug proceeds and the undercover agents involved were not actually drug	
3	dealers.	
4	The charges against Mr. Costanzo are contained in the indictment. The indictment	
5	simply describes the charges made by the government against the defendant, and does no	
6	constitute evidence.	
7	Mr. Costanzo denies the charges. ²	
8	Mr. Costanzo denies that he intended to evade federal currency transaction reporting	
9	requirements when he exchanged the bitcoins for money.	
10	Mr. Costanzo asserts that he did not rely on representations made by the undercover	
11	agents that the money involved was drug trafficking proceeds. ³
