When he purchased the Saint Kitts property, in his Saint Kitts application, which included a summary of one of his wallets, cryptowallets that starts with "One Jobe", he indicated that it had a final balance of \$3.6 million on March 1, 2018 and over the course of its existence had received more than \$560 In an e-mail to the second citizenship concierge company that Mr. Weeks enlisted in an effort to obtain Saint Kitts citizenship he wrote, quote, "the funds I used to buy the property and pay you came from me selling Bitcoins. I try to keep my money out of the banks and in Bitcoin instead. That's why the bank account has such a low balance all the time. should we do? I don't like or trust banks and I'm not a fan of fiat money. This is one of my Bitcoin addresses", and he names the One Jobe wallet. "I think I've run through \$62 million in the last year selling computer equipment that mines Bitcoin. Now you know why I don't want my US passport anymore. the tax liability", exclamation point.

We do not believe, Your Honor, that he did obtain citizenship in Saint Kitts, although he did attempt to.
