(Second Request)

Defendant Jeremie Sowerby asks the Court to continue his Detention Hearing set for November 28, 2023 at 9:30 a.m. to the week of December 11 or 18, 2023. The government does not oppose this motion.

Sowerby was indicted on September 19, 2023 and arrested on September 22, and has been detained since then. His initial detention hearing was held on November 2, 2023, which the Court continued to November 28. Sowerby seeks additional time both to gather further information to present at the hearing, and to discuss with the government potential options for his release. In addition, Sowerby was indicted in a separate matter on November 14, 2023 (CR-23-1586-PHX-SMB), and needs to evaluate the impact of those charges on the detention hearing. Sowerby submits that the above constitutes good cause to continue the detention hearing and exceed the deadlines found in 18 U.S.C. § 3142(f)(2).
