**UNOPPOSED MOTION TO
CONTINUE DEFENDANT
JEREMIE SOWERBY'S
DETENTION HEARING**

(Third Request)

19 Defendant Jeremie Sowerby moves to continue the detention hearing scheduled for
20 December 19, 2023, and to extend the date for submission of pre-hearing memoranda, which
21 is presently December 12, 2023.

22 Sowerby files this motion because counsel has contemporaneously filed a motion to
23 withdraw, and new counsel will need additional time to prepare for the hearing and confer
24 with the government in advance to discuss potential alternatives. In addition, Sowerby was
25 indicted in another matter (CR-23-1586-PHX-SMB) on November 14, 2023, and is moving
26 to continue the detention hearing in that matter, which is set for the same date and time as
27 this case. Last, counsel understands that the government may bring additional charges against
28 Sowerby this month, which could impact the pending detention hearings and require
consolidating the hearings in what will then be three matters. Sowerby submits that the above

1 constitutes good cause to continue the detention hearing and exceed the deadlines found in
2 18 U.S.C. § 3142(f)(2). The government does not oppose this motion.
