DECLARATION OF KELLEY LANE MUNOZ

I, Kelley Lane Munoz, hereby state and declare the following:

1. I am a Deputy Federal Public Defender for the Central District of California. On August 6, 2008, the Federal Public Defender was appointed to represent the defendant, Beata Priore.

2. Trial in this matter is scheduled for April 28, 2009.

3. Based on privileged information which I cannot discuss, the Office of the Federal Public Defender has determined it has a conflict of interest preventing it from continuing its representation of Beata Priore. After internal discussion, this conflict was determined by the directing attorney for the Santa Ana office and the Chief Deputy Federal Public Defender. Therefore, I am respectfully requesting that the Federal Public Defender be relieved and that a CJA panel attorney be immediately appointed for Beata Priore.

4. On February 2, 2009, I advised Assistant United States Attorney
Lawrence Kole that the Federal Public Defender would need to seek to be relieved
from the case based on a conflict of interest and would request that a CJA Panel
Attorney be immediately appointed to represent Beata Priore. Mr. Kole advised that
appointment of new counsel is appropriate if the Court determines there is a conflict.
