1. I am an attorney at law, duly licensed to practice in the Central District of California. I am the appointed attorney of record for defendant, Irene Pemkova.

2. On February 25, 2009, this Honorable Court granted defendant permission to travel to the Czech Republic in order to obtain medical treatment. Defendant was to travel from March 10, 2009 to April 10, 2009.

3. Defendant was unable to travel on those dates for numerous reasons. Defendant reports that the chief of the medical facility was not available to treat her during those dates. Defendant further reports that she was unable to purchase tickets or reserve a car until her passport was returned to her.
