21 On July 16, 2009 this Honorable Court ordered that defendant may travel to the Czech
22 Republic for sixty days for medical treatment. Defendant was further ordered to provide her
23 travel itinerary to her counsel, government counsel and file it with the court.

24 Defendant filed a travel itinerary on March 24, 2011 indicating that she would be
25 travelling in April of 2011. However, defendant returned her passport to pretrial services
without travelling on those dates.

Defendant hereby submits her new travel itinerary for travel in May of 2011.

1 As set forth in the itinerary attached hereto, defendant will fly to Vienna, Austria where
2 she will travel approximately sixty kilometers to the Czech Republic for medical treatment. She
3 will return to the United States six days later. If however, defendant is required to stay longer for
4 additional medical treatment, she will file a travel itinerary with the new return date at the
5 earliest possible date. In any event, she will not remain abroad for more than sixty days as
6 previously authorized by the court.
