19	INTRODUCTION

21	Defendant Moses Onciu, by and through his attorney of record, Gerald M. Werksman, hereby	
22	presents this memorandum setting forth all the factors that the Court should consider in determining the	
23	type and length of sentence to comply with the statutory directives set forth in 18 U.S.C. § 3553 (a) as

There are three components to the informed sentencing of a defendant in a criminal case -- the facts of the case, the applicable sentencing law, and the character and history of the defendant. The Court sat through the trial and heard all of the evidence. Although the Defendant did not testify, the Court heard him on the tapes and also heard his explanation and apology in a statement to the F. B.I. a

 year later. This Court has had great experience in sentencing defendants and is familiar with all the directives in a case such as this.

For the above reasons, this memorandum will treat the facts and law in a summary fashion and concentrate on the Defendant's character and history. It is a compelling history and the Defendant is of an exemplary character, as will be seen from the volume and substance of the letters attached as exhibits hereto.

II FACTS OF THE CASE

On pages 7-11, paragraphs 16-37, of her report to the Court dated December 17, 2013, the probation officer has set forth the facts of the case. With minor nuances, this statement is accurate. However, the following facts bear emphasis as the Court considers the Defendant's comparative role in the proven scheme and conspiracy.

- 1. Defendant's activities in furthering the TSI proposal were limited to one telephone conversation, that of December 4, 2006. He made no follow up calls to promote the scheme, and it is possible he would have never have spoken to Agent Reitz again, had Reitz not called him four weeks later. Unlike the other two Defendants, Reitz never met Onciu and it was only at Reitz's insistence that Onciu was involved in the December 4, 2006 telephone call.
- 2. Regarding the December 4, 2006 telephone call, the Defendant was ambiguous at best regarding whether Reitz should participate in the TSI venture. Onciu told Reitz he knew nothing about the company and that most HYIPs were scams and that Reitz had an obligation to do his own due diligence, never relying on anyone else in such an important decision.
- 3. Paragraph 28 of the report minimizes the importance of the references Onciu made to Reitz obtaining the services of a lawyer. It can be assumed that Reitz, the heir to a fortune and responsible to his siblings, would have the capacity to have his own lawyer and know what to ask him regarding investing a million dollars in an overseas venture. The very volume of the referrals to obtaining a lawyer should suffice to show Onciu's good intentions in this respect rather than a nitpicking at the general nature of Onciu's advice.

- 4. The charitable organization to satisfy that requirement of the proposed deal is the only reason that Moses Onciu got involved in the first place. It was Pemkova who suggested Onciu's charities, which as the court will see are very real, as the recipient of any profits. Onciu's offer to reduce any amount he received should not be misconceived as a sales pitch; rather it was his attitude towards the entire transaction and indicative of his peripheral role.
- 5. Regarding Pemkova's initial statement to Reitz, that Onciu was a former CIA operative and that his foundation was under the CIA "umbrella" (paragraph 21, page 8 of the Report), it should be noted that not only did Onciu deny CIA involvement to Reitz in the most vigorous terms and at his first opportunity, but he also chastised Pemkova at a subsequent time; we know this because Pemkova told Reitz that Onciu had done so.
- 6. Finally, while Defendant has maintained that he never intended to swindle any one and pled not guilty and went through a trial by jury, he did accept responsibility for his actions when he was interviewed by telephone by Agent Reitz, in December, 2008. At the end of an exhaustive interview (reduced to seven and one-half pages) and at a time that Onciu thought Thomas Moore was a real person, and with no indication that he was a prospective Defendant, Onciu told the agents the following:

None of MO's statements were intended by him to be misleading but he recognized that they came out that way. If MO made misleading statements, it was because he desperately wanted to fund his foundation to help feed the homeless.

MO feels horrible about this whole thing MO apologized to writers, and wants to apologize to Moore, for his misleading statements. MO did not intend for his statements to be misleading at the time, but it is so easy to get caught-up in the whole HYIP world.

It is so hard to tell anything apart because all the numbers that people talk about – either making millions or losing millions – are all so ludicrous in the context of fact that MO has never seen a HYIP deal work in the past and so many people are out there lying about their abilities to either invest in a HYIP or make a HYIP work.

(Pages 7-8, FBI report of December 19, 2008, as reported by Agents Reitz and Bomgren).

III.

SENTENCE CALCULATION

Title 18 U.S.C. §3553, factors considered to make this determination include: 1) the nature and the circumstances of the offense and the history and characteristics of the defendant; 2) the purposes of sentencing; 3) the kind of sentences available; 4) the United States Sentencing Guideline calculation; 5) pertinent policy statements; 6) the need to avoid unwarranted sentence disparities; and 7) the need to provide restitution. 18 U.S.C. §3553(a).

In considering §3553(a) factors, a court may consider formerly discouraged factors or facts that would not have met pre-<u>United States v. Booker</u>, 543 U.S. 220 (2005) standards for departures. See <u>United States v. McBride</u>, 434 F.3d 470, 476 (6th Cir. 2006) ("Now, because the Guidelines are no longer mandatory and the district court need only consider them along with its analysis of the section 3553(a) factors... many of the very factors that used to be grounds for a departure under the Guidelines are now considered by the district court- with greater latitude- under section 3553(a)."); see also Booker, 543 U.S. at 301 (Stevens, J., dissenting) ("[T]here can be no 'departure' from a mere suggestion.").

As set forth in the pre-sentence report and the next section of this memorandum, all §3553(a) factors, considered together, warrant a sentence substantially less than the Sentencing Guideline range.

IV THE GUIDELINES

"[T]he Guidelines factor [should not] be given more or less weight than any other. While the Guidelines are to be respectfully considered, they are one factor among the §3553(a) factors that are to be taken into account in arriving at an appropriate sentence." <u>United States v. Carty</u>, 520 F.3d 984, 991 (9th Cir. 2008). Thus, all of the other considerations set forth in §3553, including the history and

characteristics of Onciu are of equal importance as the guidelines range, if used. See Booker, 543 U.S. at 246; see also United States v. Ranum, 353 F. Supp. 2d 984, 990 (E.D. Wis. 2005). As one court noted,

Surely, if ever a man is to receive credit for the good he has done, and his immediate misconduct assessed in the context of his overall life hitherto, it should be at the moment of his sentencing, when his very future hangs in the balance. This elementary principle of weighing the good with the bad, which is basic to all the great religions, moral philosophies, and systems of justice, was plainly part of what Congress had in mind when it directed courts to consider, as a necessary sentencing factor, 'the history and characteristics of the defendant.'

SECTION 3553(A) FACTORS CONCERNING THE NEED FOR THE SENTENCE IMPOSED

The next factors under §3553(a) concern the need for a particular sentence. The mandatory principle of §3553 is a limiting one: the sentence must be "sufficient, but not greater than necessary." The court must consider the need for the sentence imposed--:

(A) To reflect the seriousness of the offense, to promote respect for the law, and to provide just punishment for the offense; [¶] (B) to afford adequate deterrence to criminal conduct; [¶] (C) to protect the public from further crimes of the defendant; and [¶] (D) to provide the defendant with needed educational or vocational training, medical care, or other correctional treatment in the most effective manner.

18 U.S.C. §3553(a)(2) (emphasis added).

Courts across the country have recognized that they must honor this provision. <u>See, e.g., Carty,</u> 520 F.3d at 991; United <u>States v. Spigner,</u> 416 F.3d 708, 711 (8th Cir. 2005).

As the Supreme Court has explained, the Guidelines are now just "one factor among several courts must consider in determining an appropriate sentence." <u>Kimbrough v. United States</u>, 552 U.S. 85, 90 (2009). Further, the Court of Appeals for the Ninth Circuit stated, "The district court may not presume that the Guidelines range is reasonable." <u>Carty</u>, 520 F.3d at 991; <u>see also Nelson v. United States</u>, 555 U.S. 350, 352 (2009); <u>Rita</u>, 551 U.S. at 351; <u>Gall</u>, 552 U.S. at 50. Thus, even if applicable in

the instant case, there is no presumption that the guideline range sets forth a sentence that is reasonable and meets the goals of §3553(a).

However, for the reasons set forth herein, this Court should disregard the Guideline calculation in its entirety in the instant case.

V

THIS COURT SHOULD EXERCISE ITS AUTHORITY UNDER KIMBROUGH

The Sentencing Guidelines were intended to "reflect a rough approximation" of a sentence that meets the purposes of §3553. Kimbrough, 552 U.S. at 562. However, there are times when a Guidelines calculation fails to properly embody those goals. See Rita, 551 U.S. at 351. In recognizing the potential for this type of discrepancy, Rita made clear, and Kimbrough affirmed, that sentencing courts are free to disregard the Guidelines' recommended sentence in any particular case, and may impose a different sentence based on a contrary view of what is appropriate under §3553(a). this broad discretion exists because district courts have a co-equal role with the Sentencing Commission. As the Supreme Court set forth in Rita, "the sentencing statutes envision both the sentencing judge and the Commission as carrying out the same basic §3553(a) objectives, the one, at retail, the other at wholesale." Id. at 348.

The Guidelines calculation should be given minimal consideration in the instant case because: 1) the loss calculations in the Fraud Guidelines,³ and the subsequent amendments, are not based on empirical evidence or national experience, and 2) even if properly promulgated, the Fraud Guidelines fail to adequately reflect §3553(a) considerations.

A court may choose to disagree with the Guidelines where the Commission did not act in the "exercise of its characteristic institutional role" when promulgating the Guidelines in question.

The Supreme Court in <u>Rita</u> noted, "As far as the law is concerned, the judge could disregard the Guidelines..." <u>Rita</u>, 551 U.S. at 353. Similarly, in <u>Kimbrough</u>, the Supreme Court noted that the government acknowledged that sentencing courts may now "vary [from the Guideline ranges] based solely on policy considerations, including disagreements with the Guidelines." <u>Kimbrough</u>, 552 U.S. at 101.

Kimbrough, 552 U.S. at 109. The Commission's institutional role has two components: (1) reliance on empirical evidence of pre-Guidelines sentencing practice, and (2) review and revision of the Guidelines in light of judicial decision, sentencing data, and comments from participants in the field. Rita, 551 U.S. at 349-350. Thus, post-Kimbrough, if a guideline was not developed based on "empirical data and national experience," or was not revised based on problems which arise after its implementation, the district court may disregard the guideline. Kimbrough, 552 U.S. at 109; see also United States v.

Mitchell, 624 F.3d 1023, 1030 (9th Cir. 2010) ("As the Supreme Court through Booker, Kimbrough, and Spears has instructed, and as other circuits that have confronted the crack/powder variance in the sentence of a career offender have accepted and clarified in their circuit law, sentencing judges can reject any Sentencing guideline, provided that the sentence imposed is reasonable."); see also United States v. Corner, 598 F. 3d 411, 415 (7th Cir. 2010) ("We understand Kimbrough and Spears to mean that district judges are at liberty to reject any Guideline on policy grounds—though they must act reasonably when using that power.").

VI

DEFENDANT'S CHARACTER AND HISTORY

A person's true character and past history are best learned from those who know him over a period of time. The letters attached hereto as Exhibits will give this court the necessary information regarding the defendant to make the appropriate decision in this case. Knowing how diligent this court is in arriving at the appropriate disposition, we are confident that it will take the time to read all of the letters. All are the voluntary outpouring of those who know and care about Moses Onciu.

A list of the exhibits with a summary of contents follows:

<u>Exhibit "A"</u> A seven page letter from the defendant. This letter recaps defendant's childhood history, his military service, business background, service in the ministry and his views of his present situation.

Exhibit "B" A four page letter from the defendant's wife, Rev. Mary K. Onciu. It describes a beautiful marriage, a responsible and caring father and enumerates the many random acts of kindness that exemplify the defendant's attitude toward life. Especially significant is the work defendant does with homeless veterans.

Moses regularly assisted the homeless, especially homeless vets, with getting jobs by helping them to fill out job applications, taking them to a church that offered showers, and helping them to get appropriate, clean, free clothing at another ministry.

Moses works well with his homeless fellow veterans and from time to time is notified of one who has died and has no one to attend his funeral. Moses attends these funerals of fellow soldiers so that no soldier goes to his final resting place alone.

(Pp. 3-4).

Exhibit "C" A two page letter from Chaplain David T. Isfan, Dept. of the Army. The chaplain is a nephew of the defendant who has known defendant for over twenty years. In addition to his fine character and desire to assist others, the chaplain cites the defendant's special interest and attention to veterans. "He has been at multiple homeless veterans funerals because he believes no Soldier should be buried alone. In the ARMY this is called loyalty, duty, respect, selfless service, honor, integrity, and Personal Courage. These are the ARMY values which Moses mirrors every day as he serves the community."

Exhibit "D" A two page letter from Lydia Levy, defendant's oldest daughter and two-page letters from David Onciu and Matthew Onciu, defendant's sons. Both letters attest to defendant's fine family qualities, devotion to his church, to helping others through the food bank and his love for this country and its institutions.

To cite a paragraph from Lydia's letter:

My father is my hero, my rock. He is a God-fearing man who loves his family more than anything. Everything he does is for God and his family, and not for personal gain. He is fiercely loyal to his family and protective of them. Always looking out for everyone's best interest. He is loving, giving, stubborn, humble, strong, smart, considerate, a by-the-book kind of guy. He is trusting, and believes everyone is good and deserves a chance and even a second chance.

Among the things David has written is the following:

We helped our dad and stepmom feed the homeless for years while I was at home. They also regularly provided food to the needy through their food distribution ministry. He is the type of man who would give the shirt off his back to help someone in need. I can personally testify that he once gave a barefoot veteran the shoes off of his own feet because the man had no shoes and was burning Arizona sidewalks. Helping those in need taught me many valuable things.

Matthew Onciu lives in Hawaii and works for the National Security Agency, his brother David is awaiting clearance so he can begin his career with the NSA. Such clearances are a reflection on the moral training given them by their father. Matthew makes the following comments regarding his father's patriotism and love of country:

Watching my dad and learning from him, I wanted to follow in the same footsteps as him. He is one of the most patriotic persons I know and he instilled these values in us to love our country and what it stood for – liberty and freedom. He loves his country as he never had these freedoms in his country of birth, and this is something I will never fully understand the way he does. That is why he joined the army and the stories that he told that made me want to serve my country...I applied and was accepted into the National Security Agency and serve my country proudly, just as he has done.

Exhibit "E" A two page letter from Frank Beltran, defendant's business partner for over ten years.

Exhibit "F" Six letters from people who have either assisted the defendant in administering his food bank program, been recipients of the food bank, or both. These letters attest to the reality of the food bank, its impact on others and the defendant's role in making it happen.

Exhibit "G" Two one page letters from fellow clergymen of the defendant in the Phoenix area. One is from Reverend Borea, the other from Rabbi Harris. Each letter confirms the reputation of the defendant for the charitable work he does in the community. More importantly, both Pastor Borea and

Rabbi Harris have offered to supervise and be responsible for the defendant's actions were he to be sentenced to community service. Regarding the need for his work in the community, Rabbi Harris stated: "The work he does is very important and sorely needed by the families he provides support for. Many of these families do not qualify for any other assistance and his work is all they can depend on each week to get them through."

Exhibit "H" Twenty-four letters from parishioners, family members, long-time friends, short time acquaintances and people whose life the defendant has touched in one way or another. These resulted from the gentlest of requests, no prompting from counsel and because so many people wanted to make their sentiments heard regarding the defendant.

VII

CONCLUSION

Defendant is a fifty-seven year old minister whose health is deteriorating. His role in the instant offence was minor and fleeting. He has no prior record and served his country honorably and well for over thirteen years. His financial condition is poor, but his prospects for continuous service to the community are high. His charitable endeavors are consistent with altruism at its highest level --no thought of return compensation. While the ultimate sentence is the court's alone to determine, we would respectfully submit that allowing the defendant to stay in the community, perhaps under the supervision of a fellow clergyman (see letters at Exhibit "F") or a period of home confinement would be consistent with sentencing guideline consideration's and, more importantly, allow defendant to continue his service to those in society who need it the most.

It is with a heavy heart that I write this letter to you. I would like to thank you for the opportunity to present my life and work to you for consideration. Please accept my apologies for the length of these pages, but it is hard to encapsulate a life's work in but a few pages.

I am 57 years old, disabled, the father of six children, with three grandchildren. My wife Rev. Mary Onciu and I are ordained Ministers of the Gospel. We work in and manage several charitable projects in the Phoenix area and have pending projects in India, Romania, Serbia and Philippines.

Each of my children is employed and active in their communities.

- Lydia Levy, now 35, my oldest, is a mother of 3 (one special needs child) and works part time in sales at High Health in Phoenix AZ, where her husband, Charles Levy, is director of graphic design and has worked there for over 18 years. Recently Charles applied for and is in the final vetting process by the NSA. He is almost through the process and will be hired when hiring allocations are released.
- David Onciu, now 28, lives in Hawaii and recently completed his vetting for work with the NSA, and will be eligible to be hired once the allocations are released again. Currently he is engaged as a technical contractor in Hawaii for Xerox government (security cleared) division.
- Matthew Onciu, now 26, has been working for the NSA for over three years and is also stationed in Hawaii. He is up for another promotion this year at which point he will ask for reassignment to Japan or Korea.
- Kristen Garcia, my step daughter, now 24 works in Los Angeles and is pursuing a modeling and acting career. This year she signed with a modeling agency. She has been employed at the Dorchester hotel in Bellaire, CA as a cocktail waitress for several years while she studies acting.
- Jeremiah Onciu, now 19, started his own SEO (Search Engine Optimization) internet marketing business at age 16. He is currently working for several small and large Phoenix area businesses as a Local Internet Marketing specialist while expanding his business. At age 16, Jeremiah was the youngest member ever to be inducted into the Fountain Hills Chamber of Commerce.
- Josiah Onciu, now 15, is a home schooled high school student who is active in his church and has a passion for music, cooking and gymnastics. At age 15 he was asked to be in church leadership as a peer leader. I arranged to have him meet Robert Irvine of "Restaurant Impossible" who was so taken by Josiah's passion for cooking and his determination to one day own his own restaurant that he arranged to have Josiah hired by a local restaurateur.

I currently serve as a Minister of the Gospel/Evangelist at several Romanian churches in the Phoenix area where I preach and minister to the needs of the congregations. I am also the Head Bishop of Hope Ministries- an Ecclesiastical Corporation Sole domiciled in Nevada, which ministers to the nations. We have active ministries in Romania and India where we work with at risk children and adults.

Mary and I feed several hundred people each week through our "Valley of the SON" food pantry program which is now in 4 local cities. We provide fresh produce, meats, dairy, breads and baked goods to many families who do not qualify for food stamps or other government assistance. We also provide on-site and call-in counseling and referral services to agencies that can meet needs we cannot.

As your honor knows, I have been on supervised pre-trial confinement for over five years waiting for my trial which has been delayed time and time again (not by my choice), and has had a deteriorating effect on my health, our family, our finances and our ministry. In this time we have lost many of our international relationships, which has hurt our ministry work abroad. I have done my best to maintain the local work but without funds have had to turn over some of the facilities and work to other organizations to ensure that the community continues to be served without interruption due to my unfortunate circumstances and the lack of funds.

MEDICAL

In 2012 the stress of the ongoing extensions and the uncertainty of the case contributed to two heart traumas leading to a heart attack and deteriorating health condition. The first trauma was treated by the VA Hospital in Phoenix and I was released after a short hospital stay. The second, a heart attack, was treated by Dr. Decker Weiss, a cardiac specialist in Scottsdale, AZ. I was under his care for several months. Currently I have diminished capacity to work in any physically strenuous or stressful situation which may cause another episode.

I also had to have an operation on my ankle which required the removal and reattachment of my Achilles tendon. Unfortunately this operation at the Phoenix VA hospital left me walking with a limp. Oftentimes I need a cane for stability as my leg will give out on me from time to time without notice.

In 2011 I was operated on for a damaged meniscus and had my kneecap cleaned out. During the operation the doctors discovered that my right knee had eroded away so badly that it would require a complete knee replacement, and the left knee was not much better necessitating the replacement of both knees. Due to our financial situation I have not been able to get the operation done and VA will not do so until I reach age 65, due to internal policy and budgetary constraints. I walk with a great deal of pain every day, especially as I do not allow myself to take any statin or other powerful habit forming drugs into my body. I was declared 30% disabled by the military and the Department of Transportation in Arizona has issued me disabled plates.

Childhood

I was born on September 30, 1956 in Uzdin, Banat, Yugoslavia (currently Serbia) in a small Romanian village. When I started attending school my teacher, a die-hard communist, was notified that my parents

were Christians and refused to join the Communist Party. Each day I was brought to the head of the class and told to renounce my faith and recite the pledge of allegiance to the Communist Party. Each day I refused; and, each day I was forced to extend my hand with the fingers joined while he beat them with a thorn branch and then dipped them in brine, as a lesson to the others. During lunch the older boys were instructed to beat me. This went on for 3 years.

At age 7 my family was notified that I was to be taken from them as a "ward" of the Serbian Communist Party to be trained as a military officer due to my IQ testing where I scored off the charts. We escaped in the middle of the night, traveled to Italy and narrowly missed being arrested. We received asylum and requested immigration to USA, Canada, or Australia.

While in Italy I contracted Jaundice from the spoiled food we were fed in the refugee camps and I was hospitalized for 8 months and almost died. We were interred in and moved around Italian refugee camps for over 18 months before we were sponsored to come to the USA by World Church Service of NY. I grew up in Chicago Illinois on the south side and entered the military prior to graduation from Marie Sklodowska-Curie High School under the deferred enlistment program of the US Army.

Military

From 1975, when I joined the military at age 17, to February 1988 I was an active duty service member in the United States Army, where I felt I had found a home. I started as a Diesel Mechanic (63B) and ultimately was recruited into the Military Intelligence Corps as a linguist and interrogator (96C) after a routine test for promotion which revealed I had a natural gift for linguistics.

My first tour of duty was Korea where I served as a mechanic in three units, during two tours of duty incountry and where I met my first wife, Yi Kyong Suk which ended in divorce in 1988. When I returned from my second tour I went to Fort Carson CO and from there to the United States Army *Intelligence Center of Excellence* (USAICOE) at Fort Huachuca, Arizona. I was then transferred to Defense Language Institute (DLI) where I served three tours as a student of Russian, Serbian, Modern Standard Arabic and Iraqi dialect.

I served in Germany (5th MI Group) for three years as an Interrogator and later as a liaison with German Intelligence in a covert combined services debriefing site in downtown Munich. During my tour I debriefed numerous HUMINT sources that won me a Presidential Citation from President Ronald Regan for exceptional work that provided great benefit to the US intelligence effort.

I asked to attend the Long Range Reconnaissance Patrol (LRRP) School in Weingarten Germany with the intent of going to Special Forces school. I was recruited in country for a classified special missions unit (DELTA Support) and was sent back to the US for training. Upon learning the mission of the unit, and based on the tenets of my faith, I requested withdrawal and returned to Germany to finish my tour.

During this time I was able to obtain an unclassified video and several photographs of unknown Russian Military Equipment on Parade in Moscow from a local student who had visited the country and secretly taped the parade. Having just completed the LRRP course I realized that I possessed intelligence on numerous new pieces of Soviet equipment unknown to US Intel at the time. Over three months I created a

Soviet Military Equipment Recognition (SMER) Course that I turned over to Command. This course was then classified and used by US Military Special Forces and at the Special Forces School at Fort Bragg for a number of years.

I have received numerous awards, Letters of Commendation and medals for my 13 years of service to our Constitution, this great nation and her people. I was honorably discharged after 13+ years of active service and am a service disabled veteran.

I belong to the Korean War Veterans Association, the Vietnam Veterans Association, the American Legion, Military Intelligence Corps Association, NCOA, USAA and other veteran organizations in the greater Phoenix Metroplex and nationally. I am very active in the Phoenix area ministering to a great number of homeless street Veterans. I am a regular attendee at the VA Cemetery in North Phoenix when I am notified by local indigent veterans that a veteran has passed on without any known family.

I enquire and try to attend every burial of a veteran that has no family in the area to ensure no veteran is buried alone, without someone to bid them farewell, honor their memory, and present a final salute for their service. Unfortunately, many veterans pass on alone in Phoenix as families are often hard to identify due to the indigent nature of street veterans. As long as I am physically able I will continue to honor my brother and sister-in-arms' sacrifice with my attendance at their final call for duty until I am also finally called home.

Business

Since my discharge in 1988 I worked for the Liberty County Sherriff's Department as a corrections officer. While employed I started a Title Abstract and Real Estate Investment company and began investing in real estate. I also built a successful computer services company, which I later sold.

In Arizona I continued consulting clients in the areas of RE investment, business expansion, new product marketing, new market penetration and international business development. After traveling for several years on behalf of clients, I decided to settle down and started a computer services company "Phoenix Business Services Network (PBSN)" which I ran until the big box stores (Wal-Mart, Best Buy, FRY's, etc...) and internet vendors began a price war that I could not compete with anymore.

A few months after I closed the company I was asked by a friend to join him in a mortgage business after the ".com market" crashed and I worked for him for several years while I was also traveling abroad for the ministry trying to find funding for our projects. After the collapse of the housing bubble and the Real Estate market, I went back to ministry and business consulting.

While working in the Mortgage business I met my business partner, Mr. Frank Beltran, who invited me to go to Mexico and invest in Iron Ore mines as a means to funding our orphanage projects. My family and Mr. Beltran's family securitized assets and invested approximately \$1M dollars of our own money into the purchase and exploitation of several mining properties and formed a Mexican company to accomplish our goals. We worked for 5 years within the system to gain permits, licenses and all necessary paperwork to exploit the iron ore reserves.

While I was in China I met and contracted with two steel companies to purchase all of our iron ore. I was returning to the USA with signed contracts when I was arrested. Due to my arrest and inability to travel to Mexico to complete the contracts I defaulted on the contracts and lost the mines and our families' investments.

Also during this time I formed Allied Petroleum LLC in 1998. Until recently Allied was simply a consulting company in the oil and energy sector. Since its inception we have worked hard to establish ourselves as a viable business consulting firm. We worked slowly to gain the trust of our clients and traveled to Europe and China to establish ourselves. We also worked with several governments with their needs in mind until they began to see that our services and humanitarian slant to doing business was not a ploy, but a true indication of our desire to assist them in helping their countries to grow responsibly.

In 2011 we began an expansion to include consulting in crude oil and have since been in negotiations with several West African Nations to become possible stake holders in their national oil reserves.

It has been very difficult with an indictment hanging over my head to gain the respect and trust of these countries. However, God has seen us through and because I was transparent and open with them regarding my legal issues, we have been invited to attend meetings with the oil ministers and other ministries of several countries in West Africa (Togo, Guinea, Sudan, Cameroon, Ivory Coast, Niger and West African Republic). Our proposal of using the profits from these contracts to reinvest in the countries' core needs (education, healthcare, infrastructure, housing, clean water, agriculture and electricity) has resonated with the heads of these ministries. Unlike the major oil companies we chose to give back to the countries in the form of aid and tangible support for their people.

Currently we are in the final stages of providing Diesel and Aviation fuel to the US military through a US government contractor from our agreements within the South Sudanese government oil complex. The allocations are being worked out and should be completed before the end of February 2014.

Furthermore, we have been shortlisted to become a 40% stakeholder in the Niger oil fields and will be allowed to drill in several proven oil blocks. Although I have been unable to attend and negotiate on behalf of our company one of our agents has acted on our behalf and has met with the government of Niger and has gained for us a very secure position in the allocation of these oil blocks.

Ministry

Both my wife and I are licensed Ministers of the Gospel (since 2001) through IAOGI -the Independent Assemblies of God International and have been serving the local community since 1998. Mary and I, through David & Goliath International Ministries, have been working with the homeless, homebound and disadvantaged children, adults and especially homeless veterans. We have worked on the streets of Tempe, Scottsdale, and Phoenix preaching, teaching, ministering, and working with those without hope. I have helped people find jobs, purchased, repaired and provided cars (at no charge), and arranged rental housing, to those looking for a way out.

In 2004, due to my deteriorating health, we turned over the street ministry to a large church in the Scottsdale area that had the financial resources and volunteers to take the ministry to the next level, and Mary and I began a new work – a food pantry system that has expanded greatly in 9 years.

After helping a Florida pastor plant a new church in a Scottsdale low income neighborhood, Mary and I began a food bank/pantry program that started in our home and has grown to 4 cities (Scottsdale, Phoenix, Gilbert, and Glendale). Our goal was to feed those that fell through the cracks of government assistance. Since we opened these sites, with no contribution or financial assistance from any governmental or civic sources, usually paid through my business income, we have expanded to now feed in excess of several hundred people each week. We are recognized by the Phoenix food bank system and receive many referrals from local civic and governmental agencies. Our food pantries are a very much needed resource to the local economy and many of our recipients would not be able to make it week to week without these weekly assistance staples.

Internationally we have missions in India and Romania and had begun a new work in the Philippines just prior to my arrest. All of our ministries were stopped due to my arrest and the shortage of funds to complete the projects. We still maintain a prayerful relationship with these missions but cannot support them financially, at this time.

In Romania we began an orphanage building project to house approximately 140 orphaned children and also to provide local community assistance programs, eldercare and agricultural projects. We applied to the World Council of Peoples for the United Nations (WCPUN) and received multiple UN approved project numbers to build our orphanages and economic projects in Romania, Serbia (the former Yugoslavia), and the Philippines. We were seeking project funding for these UN approved projects at the time of my arrest.

In the Philippines we registered as a Non-Governmental Organization (NGO) with the government and received Corporate Non-Profit status. At the time of my arrest we were in negotiations to purchase (on a lease-buy) an unfinished resort project in Nasugbu, Batangas, Philippines which would have been able to house in excess of 400 orphaned and at risk children and adults. After my arrest negotiations stopped, we lost the property and have been unable to fund the project. Two years later the project was sold to a Chinese developer.

In India we were approached by the Bishop of Dayana Orphan's Home Ministries of Secunderabad, Andhra Pradesh, India who asked Hope Ministries, our ministry evangelism organization, to merge with them and to found a new ministry "New Hope Ministries (India). As your honor may remember I asked to be allowed to go to India and finish the scheduled crusade we had already arranged and paid for, but your honor declined, and I ministered in these cities via SKYPE to keep my word. Today this ministry has almost doubled in size and is actively working not only in the orphan's home, community support services, and church planting, but has constructed a new church in a local leprosy colony. This church provides free hot meals on an ongoing basis, counseling, community services and church services to the inhabitants of the leper colony.

In China I was invited to speak with the Chinese government's southern region child protective agency with regards to allowing Hope Ministries to train local orphanage staff in modern facility management, child rearing, medical and nutritional programs, education and other areas of concern. I was in China when the FBI contacted me and notified me that I was under investigation and I decided to come home to face these baseless charges.

Since my arrest most of our projects have either been lost or are stagnant due to lack of funding.

Sir, my immediate family and I have paid heavily for the trust I placed in the honesty of Ms. Pimkova and Ms. Priorie, whom I believed were being truthful with me at the tie. I am embarrassed and I have no words to express my regret for allowing myself to be used as a means to potentially hurt someone. This is neither who I am nor how I was raised. Honor is more than a word in the dictionary to me.

Although no monetary loss was incurred by the "investor, "my family has paid a heavy price and lost a great deal in this tragedy. My family and I have lost hundreds of thousands of dollars in investments in Mexico due to my inability to travel causing me to breach agreements I had made in China for iron ore production just prior to my arrest. Our credibility within the humanitarian community has been greatly damaged. We have had projects on hold in India and Romania for over 5 years and the children are not being taken care of as I promised them I would do. There is no more severe punishment that I could imagine than to know that by my actions I have prevented these children from receiving timely aid.

I have huge respect for the law which is why I chose to return from China to defend against these charges. I ask Your Honor to look beyond the prosecution's circumstantial case and rule on my intent. After 40+years serving my country and my fellow man, why would I destroy a life's work with lies and malice? I would not! No sane person would.

I truly regret that I trusted Ms. Pimkova and Ms. Priorie's word and believed that this was a real transaction. I regret that I ever got involved with these people and that my name and ministry were tied to them. I tried numerous times (16 I believe) during our conversation to make sure that the investor understood that I felt he had to get an attorney involved because I felt that anyone who was going to invest a million dollars in anything should verify everything before investing. My intent was to protect the investor, not hurt him, in spite of the way the prosecution presented their case.

The prosecution's case was largely based on Ms. Pimkova's misrepresentation of me and my foundation. Dr. Priorie told the "investor" that he was under no obligation to pay me because I was not involved in any way with the transaction. Dr. Pimkova told the "investor" not to tell me about any deal she was proposing to him because I was not involved with her. If I were a coconspirator with these people, why would they deny my association with them?

Furthermore, she told him not to ask me about the CIA connection because she knew it was a fabrication and she is obviously unable to tell the truth from a lie. I immediately called her and told her that her statements were untrue and damaging to me and that she had better not lie about me again, which is why she chastised the "investor" for asking. This one statement I believe was the reason the FBI pursued me and charged me as a co-conspirator in their scheme.

I do not understand how Dr. Pimkova cannot stand trial for her comments and actions because of her inability to distinguish fact from fiction, yet the prosecution was able to use those same statements against me in trial.

Your Honor, I would ask that you consider my history and contributions to the local and international communities compared to this one incident in your decision on sentencing. My history is one of service to others and not one of criminal activity. I am an honest ad honorable man, regardless of the charges against me or the findings of the jury. I believe that had I not been convinced that I should waive my right to defend myself, I would have been found innocent of these charges, as I hope to prove should Your Honor grant a new trial, or through the appeal process.

I do not know if the law even allows an acquittal after a finding of guilty, but my respect for the law is based on my belief that the law was intended to protect the innocent even in the face of such charges. Therefore, Your Honor, I ask you to look to the spirit rather than the letter of the law and to acquit me of these charges and restore my good name that I might be able to continue to serve my Lord and my fellow man.

Dear Judge Carter:

Thank you for the privilege of observing your courtroom in action during the recent trial of my husband, Dr. Moses Onciu. You run a "tight ship." I especially appreciated your outspoken respect for the American taxpayer. When I worked for the State of Arizona during the early 1980s, we were expected to treat the taxpayer as our "Boss" – a concept often lost on this generation of government employees – but still observable in your Courtroom!

Next, I would like to give you a brief background on myself. I hold in the highest regard the judicial process by virtue of being the granddaughter of a well-respected Detroit judge, Louis Ott, who I believe served during the 1910s, '20s, and '30s. My father, Frank Wery, was a well-known and trusted lawyer in Lansing, Mich., during the 1950s, '60s, and '70s, and I worked for him as a legal secretary while putting myself through Michigan State University in the '70s. I graduated magna cum laude with a B.A. in Communication Arts and Sciences in 1976. For the next 20 years, I worked as a reporter, editor, corporate and government public relations professional, and public relations consultant, including a stint as press secretary to a U.S. Congressional candidate.

I married Moses in 1993 and, for the last 20 years, I have been a full-time mom to our six children and "Grandma" to our three grandkids. For that entire time, we have lived in the same 1,460-square-foot, two-story townhome owned by Moses' dad and mom. "Grandpa" and "Grandma" are retired pastors who live in the townhouse next door and are still active in their church; this has produced a wonderful closeness between them and our children.

Moses and I met because I was the Children's Church leader for his three children when they moved to Arizona from Georgia after their dad's divorce. They had a void in their hearts because they were away from their mom for the first time. I had a void in my heart, also, because during my divorce, my first husband had kidnapped our only child, and I had no idea if I would ever see my precious two-year-old again (The FBI found them 18 months later.) Thus, every Sunday after church, I would hold and listen to Moses' kids, and we all benefitted from the love exchange.

Then, one Sunday, Moses returned to Fountain Hills from settling his affairs in Georgia and was late for picking up his kids. When he arrived, he tried to make amends by asking if I would join them for lunch. I agreed, and we went to McDonald's, where we talked while the kids played on the play equipment. Moses asked me what I saw myself doing eventually. Having just watched a documentary on the deplorable conditions of the orphanages in Romania, I said, "Well, you're probably going to find this hard to believe, but I see myself somehow helping the orphans in Romania. I told him about the documentary and then asked, "What do you see yourself doing?" Moses answered, "Well, you're probably going to find *this* hard to believe, but in 1978, while I was still in the army and not walking with the Lord, God woke me up in the middle of the night and told me to write His plan for building orphanages all over the world, starting in Romania!

I wrote the plan down and sent it to my dad, the senior pastor of a Romanian Pentecostal church in Chicago, thinking the plan had to be for him, not for me! It's still in his filing cabinet."

Of course, we both saw the spiritual significance of this God-ordained "coincidence." Three months later, we were married. Five years later, in 1998, as we prepared for the birth of our second son, God woke Moses up again, this time telling him to start the orphanage-building ministry and to call it David & Goliath International Ministries (DGIM). One of our Romanian board members had already begun building an orphanage project in Timisioura, Romania, but he had run out of funds after completing the church and the foundation of an orphanage building that would house 140 children. On a trip to Romania with this board member, Moses toured a local garbage dump, where many of the orphaned children resided in "caves" in the foul-smelling garbage. Others lived in the sewers. Some, high on the glue they sniffed to dull the pain, died on the streets in the freezing temperatures. Moses arrived home in shock and with renewed resolve to help these children.

It quickly became evident that the problem of impoverished children stretched far beyond Romania's borders and would require tremendous amounts of money to remedy on a global scale. As Moses traveled on business, he began to develop contacts all over the world who might help us to develop the ministry in their countries. Moses also began to pursue various non-traditional funding sources in an effort to raise the finances both for the initial orphanage projects in Romania and the Philippines as well as for later projects that would also help the widow, the homeless and, in the case of India, the leper. A Christian bishop in Secunderabad, India, who Moses met through a business associate, brought his ministry under DGIM in 2008, after he and his 250-plus pastors prayed and unanimously felt led by the Holy Spirit to do so. That ministry oversees an orphanage for 100-plus children and a feeding/assistance program for a leper colony.

I have been registered with Maricopa County as a home-schooling teacher for 12 years, and Moses is the principal of the Onciu Family Home School. Since 2001, like Moses, I have been a licensed and ordained minister of the Gospel of Jesus Christ under the Independent Assemblies of God International. At church, I have been a Sunday School teacher, Children's Church leader, Missionettes leader, Vacation Bible School teacher, and Women's Bible Study teacher. Since marrying Moses, I have been actively involved with him in nursing home ministry, homeless ministry, jail ministry (Maricopa County) and, since 2003, a food distribution ministry. The latter we launched, grew, and continue to manage. Moses is there every weekend as we serve the needy out of several area churches of different denominations.

Moses has been a responsible and caring father to our six children, three of whom were from his first marriage; one of whom was from my first marriage; and two of whom we had together. In his divorce settlement, Moses' first wife received the assets, and Moses received full custody of their three children – her idea, to which he happily and willingly agreed. I raised Moses' daughter from the age of 15, and she has now been happily married to the same man for 17 years; she is employed part-time and is the mother of our three grandchildren. I raised Moses' two sons from the ages of 6 and 7 years old; they are both happily employed by major entities. Moses has treated my daughter from my first marriage as if she were his own. She is profitably employed full-time for a luxury hotel in Bellaire, Calif.

The older son of our union has thrived under the business training and watchful eye of his dad. He started his own successful internet marketing/P.R./S.E.O. business when he was 16 – the

youngest member ever of the Fountain Hills Chamber of Commerce and the subject of a feature story in the Fountain Hills *Times*. Our son says he was inspired by the entrepreneurial business experiences his dad had and talked about while he was growing up. Our son's company is going strong three years later, and he gives credit to his dad, Moses, as his inspiration for operating at the highest level of integrity. Having his dad go to prison might send him into a tailspin.

Our youngest son is 15 and still in home-school. His dad supports and encourages him in all of his interests and endeavors. When our son said, at age 14, that he'd like to own a restaurant some day, Moses got him an interview with Restaurant Impossible star Robert Irvine, who was in town to shoot a show at one of our fine-dining Italian restaurants. Irvine was so impressed with our son that he introduced him to the restaurant owner, who said she saw a "fire" in him that would give him his own Food Network show some day. She hired him on the spot as a busboy! This son has served in leadership at our church for the last three years. If his dad goes to prison, the feelings of abandonment might be emotionally damaging to this upstanding young man in his sensitive teen years.

I am writing this letter on Thanksgiving Day 2013, and I thank God for giving me a husband, Moses Onciu, who is an old-fashioned man of integrity, courage, and compassion. If one's character is measured by how one acts in private, I am one of the few who would be aware of Moses' *true* character. I offer these examples:

- When Moses sees someone broken down in their car by the side of the road, he invariably stops to see if they are okay and does whatever is necessary to help them.
- When Moses and I were driving home one time, we saw a Hispanic woman and several children walking along the side of the road near our town in the *northeast* Phoenix area. Moses stopped to see if they were okay. He discovered that the man they had been with had abandoned them at a nearby lake. They had walked more than 10 miles from the lake to our town in the rain. When Moses learned that they lived in the *southwest* Valley, he offered to take them home, and we drove for more than an hour to ensure their safety.
- Last year, a drunk and distraught, Native American man walked into our home through the back door. Our 18-year-old son calmed him down and led him back outside, where my husband ministered to him, led him to the Lord, and drove him back to his home.
- On an airline flight, when a baby continues to cry for some time, Moses will go to the mother, ask if he may hold the baby, and walk the baby up and down the aisle until he/she goes to sleep much to the relief of the other passengers.
- When we were doing homeless ministry, I saw Moses give the Dr. Scholl's casual shoes
 off his own feet to a man who had no shoes and who wore the same size and extra-wide
 width that my husband wears. The next week, someone donated to our ministry a new
 pair of those same Dr. Scholl's casual shoes in the same size, extra-wide width and color!
- Also during the time of our homeless ministry, my husband kept his cell phone on 24/7. On one occasion, a mother called who had been kicked out of her home by her abusive husband. She and her two children were huddled under a bridge in south Phoenix when Moses rescued them; he took them to a shelter for abused women.
- Moses regularly assisted the homeless, especially homeless vets, with getting jobs by helping them to fill out job applications, taking them to a church that offered showers, and helping them to get appropriate, clean, free clothing at another ministry.
- On our way from Phoenix to Prescott, Moses spotted two of our homeless men riding their bikes along the side of the I-17 freeway, going in the same direction that we were.

He stopped, put their bikes in our van and gave them a lift to Prescott, where we bought their dinner and listened to their stories of sharing the Gospel with other homeless men.

- Moses would visit our homeless men in the hospital, ministering to them and praying with them.
- To this day, Moses gets phone calls from some of the homeless men to whom we ministered during that five-year period from 2001-2006; Moses counsels them and prays with them.
- Moses works well with his homeless fellow veterans and from time to time is notified of
 one who has died and has no one to attend his funeral. Moses attends these funerals of
 fellow soldiers so that no soldier goes to his final resting place alone.
- Since we started our food distribution ministry 10 years ago, I have seen Moses deliver countless food boxes to the homes of needy people, ignoring his painful, arthritic joints to carry heavy boxes of food up flights of stairs to their apartments. He still does this today.
- On a business trip to Mexico, a business colleague called Moses to come pray for his very sick father. Moses told him that he only spoke basic Spanish and did not have the vocabulary to discuss matters of faith in Spanish. The colleague asked him to come anyway. When he got there, Moses began to minister in Spanish and suddenly found himself speaking fluently about matters of faith, even quoting from the Bible in perfect Spanish. He led his colleague's father to the Lord, and the man died two weeks later.
- Moses is currently a guest preacher and evangelist for three Romanian churches in the northwest Phoenix area. He is able to preach in English or Romanian, his native tongue.

Moses has been a faithful and devoted husband, helping me in so many thoughtful ways every day. For example, due to whiplash injuries from several accidents, I am not able to stand on the tile floor in the kitchen for more than 45 minutes without severe pain in my back. My husband often washes and chops ingredients for me, so that all I have to do is the cooking. He also shares the dish-washing responsibility with our 19-year-old son and lunch-making with our 15-year-old son. Moses is a gentleman, always opening doors for me, seating me at restaurants, helping me with my coat, etc. He also loves to bring me fresh flowers and spontaneously asks me to dance – cheek-to-cheek -- anytime, anywhere – if one of our favorite '50s or '60s songs comes on.

Judge Carter, Moses and I are an old-fashioned couple who are truly "one flesh." We love God, our neighbor, our children, and each other with all of our hearts and have asked God to take us to heaven together when it is our time to go. I can assure you, with every ounce of knowledge that I possess about this man to whom I have been married for 20 years, that his ONLY motivation for pursuing or accepting funds has been to help the orphans, widows, homeless and lepers worldwide. In this pursuit, he would NEVER do anything that would bring shame to the name of our Savior and Lord, Jesus Christ, nor to his loving parents, wife, family, friends and fellow ministers. That is why he has no prior convictions on his record and is innocent of these charges.

My heart is breaking at the thought of losing my precious husband, and I ask you, with tears and humility, to please have mercy on Moses and on all of us who love him so much . . .

My name is David Onciu, eldest son of Moses Onciu. I am 28 years old, and I am writing this letter of testament about my father's integrity and character. Please allow me to take a few minutes of your time to explain why I believe he should be acquitted or receive a lenient sentence.

My earliest memories of my dad are of when we were living in Georgia, around the time my parents got divorced. Due to my mother's issues at the time, my dad fought hard to keep us three kids. In spite of a court that believed children belong with the mother, he was granted full custody. After the divorce was final, my dad worked hard to keep food on the table and a roof over our heads. It wasn't the best situation for me and my siblings, but we knew we were loved. Now that I have grown up, I realize how much my father sacrificed to provide and keep us kids safe. A few years after the divorce, we moved to Arizona where my grandparents lived, to get a fresh start. A few months after we arrived, my father met our wonderful step-mother at our church; she was our Sunday school teacher. He first asked all of us kids what we thought of her before he even considered dating and then, later on, asked us how we would feel if they got married. We were excited that he found a partner in life again, and knew she would be a great mother. Our dad always put his kids first before anything.

After my dad remarried, life returned to normal. We went to church regularly, where my dad was respected. We did well in school because both my dad and my stepmom would stay up late with us to make sure our assignments were completed on time. We were never spoiled, learned the value of money, and were thankful for what we had; we never focused on what we did not have.

Growing up, dinner table conversation often included my dad's Army stories. He sincerely believed that serving our country was the greatest honor and privilege of his life, besides marrying my step-mother. My dad was stern, but not harsh, in his discipline. He believed that if you spared the rod, you would spoil the child; he used old fashioned Romanian discipline. We grew up respecting our dad and fearing that we would somehow disappoint him. He and my grandfather are my role models in life, two Godfearing men the whole family respects. I wanted to be like my dad and around age 18, as I became an adult, I decided to join the Army with my best friend. My dad pulled me aside and counseled me not to join and just be a "grunt." He advised me to finish a college degree, and then to enlist as an officer. I went to college, and my best friend joined the Army. He always wanted what was best for us.

After working for a major University in the IT department for three years, my brother moved to Hawaii to pursue a career with the National Security Agency to serve his country and make my father proud. I stayed in Arizona while trying to figure what I wanted to do, as I no longer wanted a career in the field I was studying. My brother got the job with the NSA, and a year later I knew I wanted to do the same thing. I decided to move to Hawaii to pursue a career in intelligence with the NSA. I was offered a job and excited to serve our country like my dad had done. I currently work for XEROX, a fortune 500 company, as I wait for my NSA processing to be completed.

I am where I am today in life through the discipline, love and wisdom my dad gave me. He taught me to be fair and honest when dealing with other people, to help those in need if I am able to help and, most importantly, that personal integrity and honor are all we leave with in life. To my father, God, his family and duty to his country come first.

We helped our dad and stepmom feed the homeless for years while I was at home. They also regularly provided food to the needy through their food distribution ministry. He is the type of man who would give the shirt off his back to help someone in need. I can personally testify that he once gave a barefoot veteran the shoes off of his own feet because the man had no shoes and was blistering his feet on the burning Arizona sidewalks. Helping those in need taught me many valuable things.

My dad allowed me to make my own mistakes growing up, and well into adulthood, never judging me, but making sure I learned life's lessons from my mistakes. His moral compass always points true north; it is never misleading. He taught me to be honest and fair in business, to never cheat anyone, and to give the best customer service possible. His advice has had a positive impact on me and has helped me greatly in my previous jobs and relationships.

Even when he was indicted, my dad would tell the new people he was doing business with about his case, never hiding it. My dad is a very transparent and trusting person. You always had his trust from the time he meets you, and you could only lose it. As far as what he was accused of in this case, I believe he might have been too trusting and was taken advantage of.

Your Honor, when determining my father's sentence, please consider everything with an open mind and heart, especially the fact that he has already suffered through years of hardship, heartache and loss due to this case. He is older now and sick, having had two heart attacks since the indictment. He also has developed food-controlled diabetes and high blood pressure. Lastly, he has severe pain both from arthritis and from recent surgeries on his knee and Achilles tendon. I doubt that he could survive in prison.

I know you will use the wisdom God gave you, and the power the government has given you, to make the right decision. In my eyes, my father is innocent. Please consider honoring his lifetime of military, community, and church service by granting him an acquittal. If that is not possible, please consider a lenient sentence. He is needed by families in Phoenix who depend on him, and I need him. It would be a disservice to place him behind bars when he can better serve the community like he has always done. Thank you for your time and consideration.

Treat those better than yourself and make your friends like family as those bonds can be stronger than blood.

It was these values among many others that have helped me along my way. I have been complimented many times over than I could count of the demeanor I have and the manners that have seem not to be taught to children now-a-days. It is because of that, I have made many great friends and bonds as strong as blood. Even though I may be old-fashioned to some, it is the only way I could ever see myself. I have always looked up to my father, strived to be more like him, and I credit him for how I have turned out this way.

Watching my dad and learning from him, I wanted to follow in the same footsteps as him. He is the one of the most patriotic persons I know and he instilled these values in us to love our country and what it stood for- liberty and freedom. He has become well-loved in our community and has always been a force for good. It is because of his kind heart that others have tried to take advantage of him and use for their own purposes. I beseech you to look at my father for the man he is and not based what was negatively portrayed in his case. If you got to know my father you would also question what has been said about him. I hope that my letter will persuade you to be lenient in his sentencing. He has grown old and this case has already taken a lot out of him and our family mentally and physically. He has had two heart attacks and thought I had lost him once. This is a man who would do better serving his community like he always does instead of being behind bars. It would be a disservice to lock him up. Through my eyes my father is my hero and someone who everyone should have as a friend. As I have mentioned many times above it was because of my father that I am where I am today and serve my country as a patriotic duty just as he has done. I am a living testament of who my father is.

Content:

- 1. I have known and worked with Mr. Moses Onciu for over eight years, having first met him when I started to help a former manager of David and Goliath food ministries. I shared with my husband my early impressions: he genuinely cared for people and their well-being, and was concerned for those less fortunate who had to struggle to find their next meal. That's when I learned he had set up several distribution centers in various places, arranged with various food markets, farmers' markets, etc. to donate spoils rather than toss good food in the dumpsters. Over the years, our one station alone now services 30-40 families each week.
- 2. Having encountered him almost weekly in context of the food ministry, I observed the following instances of his interactions with the community and with various individuals:
 - In 2005 he helped our daughter, whose husband was abusive, and who deserted her and her four children, so her house went up for a clean sale rather than to go into foreclosure.
 - A lady one of the food ministry recipients could only take enough cold food that would fit into the two ice chests that she brought with her because her refrigerated failed, and she had no money for repair or replacement. Moses got on the phone, located a working refrigerator, and had it delivered to her home free of charge.
 - Another food ministry recipient lost her job and was left with no means of support for her family. Moses made a few calls and set up an interview. The recipient obtained the job and was able to provide for her family.
 - He often filled boxes at the ministry site and delivered them to families who had no transportation to come to the site on their own.
 - He set up a give-away table for non-food items at our site so that needy recipients had some access to shoes, clothing, educational supplies, kitchenware, etc.
 - In Phoenix summer heat often above 112 deg., he often gave rides to people who came to the site by bus, so their food wouldn't spoil while they waited for the bus on their return home.
 - He is always ready to listen to peoples' problems with the intent to do what he can to help and provide for urgent needs.
- 3. Having witnessed first-hand actions such as the above, I have observed that Moses consistently takes steps to help people while preserving their dignity and self-respect. I know few details of his current situation. I strongly suspect that his openness of spirit and quickness to jump in to help may have a significant bearing on his current situation. Perhaps you have read what it says in a very old Book:

"Ye shall know them by their fruits. Do men gather grapes from thorns, or figs from thistles?" Matt. 7:16 KJV

We, Philadelphia Romanian Church of God, located at 19781 N. Remington Dr. Surprise Az. 85374, wish to ask your honor to consider an alternative sentence for Dr. Onciu. We are a mainstream church in Surprise Arizona where Dr. Onciu ministers regularly and through which he provides assistance to many families in need through his four-site food bank and pantry, his homeless and veteran's ministries to street people, and his evangelism to those in need of someone to trust to tell their troubles to. His dedication to those in need supersedes his personal needs, and oftentimes takes time away from his family, who support his ministry work 100%.

Due to his work in the local community and especially in the Romanian Community we would like to ask your honor to consider allowing Dr. Onciu to continue to work in the community rather than going to prison. We believe that justice would be better served with him continuing his work rather that serving a prison sentence. There are dozens of families who rely not only on the food he provides, but on his willingness to come out in the middle of the night to help resolve family issues, to pray with people day and night. He has even given his personal cell number to the people he ministers to and let them know that if they are in trouble to call him day or night. Many times they have, and he has always answered.

My name is Chris Brown and I am a graduate of Iowa Christian College, on staff at Vineyard Community Church located in Orange County, California and am a business owner. I am writing this letter on behalf of Moses Onciu my long time friend. I have known Moses for 8 years and in that time have been involved in various activities including ministry endeavors with Hope Ministries, Inc. In the time I have known Moses he has always conducted himself as a professional, compassionate, kind individual with utmost professionalism.

Although this has been an extremely difficult last 6 years for Moses and much has happened with this case I would like to focus on the trial which occurred this past October of 2012. During the trial it was evident that Moses' lawyer was not able to represent his client in a professional manner. As I sat in the courtroom watching the lawyer fall asleep many times and then stumble with his words to attempt to represent Moses I knew his lawyer was not able and I could see the jury was also impacted by this. Unfortunately, Moses did not have the financial ability to hire competent legal counsel and because of this justice was not served. During the conversations outside of the courtroom with Moses' attorney the same confusion and lack of focus was evident. The jury was not being presented with the truth when it came to Moses' involvement with the other two defendants in the case. Clearly, the outcome was partially due to incompetent legal counsel. When the verdict came that Moses had been found guilty on all 6 counts, it was absolutely shocking. Moses had been guilty by reason of association yet had not actually been a part of defrauding anyone! There was so much evidence that was not included in the trial which would have given the jury a chance to see the complete chain of events.

His life work is a ministry that feeds the homeless and provides clothing and other services to the community. There have been times that he has walked into a restaurant, purchased a meal and walked back onto the street to give it to someone who had nothing to eat. I, Terry I. Major, am a friend of the defendant in this case, (Case Number: SA CR 08-180-DOC), Dr. Moses Onciu. I am of age, competent to testify, and I have personal knowledge of the facts stated herein which are true, accurate and correct to the best of my knowledge, ability and belief at this time, under penalty of perjury. I hereby depose and say the following related to this case:

I believe that I first met Dr. Onciu in 2003. A mutual friend, Dr. Roger Cahill, probably introduced us.

I have listened to Dr. Onciu explain how he had worked to set up orphanages in China, India and Romania and about his work in Mexico. I have had no financial dealings with Dr. Onciu, but understood that he was always willing to assist those in need.

It was my observation that Dr. Onciu was willing to give of himself through time and effort to run food banks where the less fortunate could obtain food to sustain their families. I have met no-one with a stronger desire to assist those in need with time, effort and concern. My specific dealings with Dr. Onciu concerned the Revaluation of the Iraqi Dinar. Two of my friends and I placed the Dinar that we had purchased with Dr. Onciu to have them transported to an individual in Las Vegas who had the necessary contacts to arrange for proper handling of the Dinar for payment and who we are assured will work in our interest to handle the revaluation that has been promised in the very near future. Everything has gone according to plan. I have received a signed receipt for the Dinar that was sent and have no reason to doubt that Dr. Onciu has performed according to our agreement.

It was our hope that the revaluation would permit us to use the resultant funds to further the ministry work of Dr. Onciu and for other humanitarian causes. We still hold on to this hope.

I believe Dr. Onciu to be of impeccable moral character. I do not believe that he would knowingly misrepresent facts when asked his opinion concerning any subject. That does not mean to say that his opinion would always be correct, but I am certain that his belief in his position would be founded upon his own research and conclusions. He would not knowingly mislead or misdirect anyone.

I have observed Dr. Onciu at one of the food banks that he runs. It appears that over at least the last ten years he has arranged a very successful method to provide food to those in need in the local community and his absence would be sorely missed!

Dr. Onciu has provided a much needed service to the community and placing him in prison would be a severe blow to the community. If there were any way to allow him to continue his community based services, the greater good would be achieved.

It is my belief that Dr. Onciu should be permitted to continue his service to the community. A form of Parole or a sentence that allows him to remain in community service would benefit the local community where, I believe, prison would not. Possibly a supervised period of time where Dr. Onciu can continue his ministry work would be beneficial to all.

Honorable Judge Carter:

I am writing this letter in reference to my brother, Moses Onciu, as a character reference. I have known Moses since I was born in 1959, and together with our younger brother, we grew up in the same European, 1st generation immigrant, household until Moses enlisted in the US Army, around age 18.

We were raised in a God fearing home (our father being a minister) that lived by the Golden Rule i.e.: "Do unto others as you would have them do unto you." Our parents not only taught us but modeled this rule through endless, self-less sacrifice for others that were less fortunate than us. Being kind and helping others, in turn, became second nature to Moses due to this upbringing.

Moses is a person of integrity and a person of his word. You can count on him and if he gives you his word he will follow through. Being his sister I sometimes become a pest and I volunteer him to fix my husband's relatives computers, knowing they do not have money. Even though he is so busy and knows he will not get paid, if he gives me his word, he will go to their house and fix their computer and he always follows through.

Moses would never take advantage of someone; he would rather lose his time and money to help others out. He is also one that you can call day or night when you are in need. He always puts someone else's interests ahead of his own. He is the one person I can count on whenever I need help and I know if I call him he will be there for me. One time, I called him in the middle of the night when my husband had an accident out of state which totalled his truck. This incident occured 3-4 hours away from where we lived and Moses dropped everything to drive me that night to go pick up my husband. He has always been someone I can count on.

Moses is a generous person and would give you the shirt off his back, if need be. I remember when we went to church one Sunday, Moses was about 16 or so, and my parents gave him \$10 (that was a lot of money then) and they said "Moses you need to keep this money in your wallet just in case something comes

up so you have some money on you." When church ended and the ice-cream truck came around Moses didn't go and buy ice cream just for himself, he went and bought ice cream for all the little kids around him. That is how big his heart was and how he still is today!!

Moses is also a great father and is family-oriented. When he and his first wife went through their divorce, he told her all he wanted was the 3 children (the youngest being 5). She did just that she took the assets and gave him the children. Moses was the one that cooked, cleaned, made lunches, did homework, stayed up all night when they were sick, etc (I know this because I lived near them at the time he was divorced). Moses raised them all by himself for many years being both mother and father for them, until he met and married his current wife Mary, who was a true mother to his 3 children after that.

Another great characteristic trait that Moses possesses is having a servant's heart. He is always there to serve and help the community and has passed that down to his children. He has served the community endlessly through many volunteer ministries, where he gives up thousands of un-paid hours to serve in prison ministry, running a food bank, feeding the homeless and many more.

He built up a service ministry that increased to over 120 homeless in Phoenix and Tempe, and then found a church that was willing to take on the responsibility to take care of them when it grew too large for him and Mary to manage.

He helped a pastor from back east start a church in South Scottsdale in a "Bario" and helped them grow. Then he started a food bank (over 11 years now) that is serving the needy in 4 local communities.

What has left a lasting imprint on me is the way Moses whole-heartedly served and fed the homeless, especially the homeless veterans. He did this not just by himself but he would go together with his wife and bring their children. They would not only prepare hot food at home to bring the homeless a hot meal, but they would minister sit and talk to the people for hours at a time after serving them the meal. Their children at young ages would be with them every Saturday and would help serve the meals and then would talk to the people along side them.

Moses and his wife modeled true compassion for those less fortunate than themselves. They would also go above and beyond just feeding them, by getting involved in trying to help these people get back on their feet, find jobs, cars, housing, and furniture, etc... Moses bought, repaired and gave away at least three cars to help people get back to work. This is what impressed me the most that it was not just a chore for Moses, it was from his heart.

I can truly say that Moses is someone I look up to and am proud of. He is a man of great character and integrity and is a man of his word. He is generous,

compassionate and a wonderful father and husband; but most of all he has a servant's heart and always is looking for a way to help others and to put the interests of others ahead of his own. I hope that through this letter you can see Moses' true heart.

Your Honor, I would respectfully ask that in determining Moses sentence if you could consider that it would be a great loss to the community if Moses would be imprisoned. His time that he devotes to running the food bank is something that would be hard to replace and the food bank might have to close. Also, the many ministries that he so whole heartedly serves would also suffer. I know that if he were to serve his sentence time doing community service the community would benefit much more than if he would be imprisoned.
