SECOND MOTION FOR TRANSCRIPTS

MOTION TO DENY PRE-TRIAL  
COMPLIANCE DATE

I, Desiree Saunders, being a party to the above case, do hereby request a copy of the sealed transcripts from the hearing that was held on March 30, 2010, April 6, 2010 and April 22, 2010, before Judge Frederick J. Martone.

The Governments response on the 12<sup>th</sup> day of July, 2010 are misleading if not downright lies. This court to my knowledge has not granted me access to the sealed transcripts of March 30, April 6, and April 22, 2010, with Judge Martone.

I personally talked to the transcriber, Mr. William A. McNutt III, before my submittal of the July 6<sup>th</sup> Motion to this court to give me an order to get a copy of the transcripts, who told me because of them being sealed, he would not release the transcripts without a court order.

After receiving the government's response on the 12<sup>th</sup> day of July, which it stated that the court granted me access to the transcripts, I again attempted to contact the transcribers office to get the transcripts and found that Mr. William A. McNutt was away on vacation and was to be back on the 21<sup>st</sup> day of July.

1 I called the transcriber Mr. William A. McNutt, on July 18,  
2 2010, while he was on vacation, who related again, under no  
3 circumstances would he issue me a copy of the transcripts  
4 without an order from the court and he had not received an order  
5 as of to date.

6 Mr. McBride and I have both sent in motions to have the court  
7 order the sealed transcripts released to us. I am prepared to  
8 pay for this service, if need be, once the court sends an order  
9 to the transcriber, or me saying we are allowed a copy.

10 Without having all of the transcripts, I do not have enough  
11 information to form a reliable objective response. To be denied  
12 the transcripts in their entirety is very unreasonable and  
13 oppressive and impairs my ability by leaving out pages of the  
14 actual transcripts.

15 Due to this fact I am requesting the court to re-schedule a  
16 show cause hearing on why the Subpoena Duces Tecum should not be  
17 quashed, after the court has Ordered the Transcriber to send me  
18 a copy of all of the transcripts to review before any hearing is  
19 scheduled. I will need at least thirty days from receiving the  
20 transcripts to either answer or appear, whichever the court  
21 sets.

22 Upon receiving and reviewing these transcripts, I will be able  
23 to form reliable objective responses, which would otherwise be  
24 very unreasonable and oppressive for me to accomplish.
