I called the transcriber Mr. William A. McNutt, on July 18, 2010, while he was on vacation, who related again, under no circumstances would he issue me a copy of the transcripts without an order from the court and he had not received an order as of to date.

Mr. McBride and I have both sent in motions to have the court order the sealed transcripts released to us. I am prepared to pay for this service, if need be, once the court sends an order to the transcriber, or me saying we are allowed a copy.

Without having all of the transcripts, I do not have enough information to form a reliable objective response. To be denied the transcripts in their entirety is very unreasonable and oppressive and impairs my ability by leaving out pages of the actual transcripts.

Due to this fact I am requesting the court to re-schedule a show cause hearing on why the Subpoena Duces Tecum should not be quashed, after the court has Ordered the Transcriber to send me a copy of all of the transcripts to review before any hearing is scheduled. I will need at least thirty days from receiving the transcripts to either answer or appear, whichever the court sets.

Upon receiving and reviewing these transcripts, I will be able to form reliable objective responses, which would otherwise be very unreasonable and oppressive for me to accomplish.
