

 12 Janice Sue Taylor, respectfully requests that this Court
 13 extend the time for filing of pretrial motions for a period of
 14 sixty (60) days from the current date of October 20, 2010. In
 15 addition, defendant requests that the Court continue the trial
 16 date for a period of sixty (60) days from the current date of
 17 December 7, 2007. The reason for the continuances is to allow
 18 additional time to find an attorney to represent defendant, and
