MOTION FOR ENLARGEMENT OF TIME AND ORAL HEARING.


Comes now, Janice Sue Taylor, a living woman, not a corporation or other type of artificially created person, and not domiciled in the district of Columbia OR any other United States of America territory; hereinafter the Movant, by Special Visitation or Appearance, not Granting jurisdiction nor recognizing this court's right to try her; but intervening in a foreign jurisdiction on behalf of the Alleged Defendant, Persona JANICE SUE TAYLOR, hereinafter the Accused. 7 compliance with the Bill of Rights. Therefore this request for an enlargement of time on all
8 proceedings is required in order to preserve Movant's inalienable due process rights.


