**UNITED STATES' NOTICE RE:
UNTIMELY DEFENSE MOTIONS
[docs. 166, 172, 177, 179]**

16 The United States, through undersigned counsel, respectfully files this notice regarding
17 several motions Taylor has filed after the Court ordered motions deadline of October 22, 2010
18 [doc. 120]. We refer specifically to Taylor's motions to (1) compel prosecutor to answer
19 admissions [doc. 166, filed November 16, 2010]; (2) enlarge time for all proceedings [doc. 172,
20 filed December 14, 2010]; (3) to inspect jury list [doc. 177, filed December 28, 2010]; and (4)
21 to dismiss for lack of in personam jurisdiction [doc. 179, filed January 3, 2011].^{1/} Because
22 these motions are all untimely, the United States respectfully declines to file responses to them
23 and any others which may be untimely filed until or unless the Court extends the motions
24 deadline or otherwise indicates its wish that the United States respond.

25 We note that Taylor has filed a motion to extend the motions deadline [doc. 125]. The
26 United States has responded in opposition [doc. 134] and that motion, along with fourteen others

28 119]. Both a response [doc. 133] and reply [doc. 147] have been filed and the motion awaits
hearing on January 12, 2011.

1 that were filed before the motions deadline, is pending. The Court has set January 12, 2011 as
2 the date upon which these pending motions will be heard [doc.176].
