17 this Court grant the government an extension to respond to Defendants’ Joint Motion To Compel  
18 or Exclude Discovery (CR 44), and Defendants’ Joint Motion For Bill of Particulars (CR 46)  
19 filed on December 23, 2010 respectively. The government seeks an extension until February  
20 7, 2010.

21 The government seeks this extension as undersigned counsel is currently on trial before  
22 Hon. Susan R. Bolton in *United States v. Flores-Angles*, CR: 10-0506-PHX-SRB, which is  
23 scheduled to finish on January 11, 2011. Undersigned counsel will also be preparing and  
24 appearing for trial before Hon. Roslyn O. Silver on January 18, 2011 in *United States v. Jason*
