1:27 p.m. Court reconvenes. Jury is not present. Joy Bertrand addresses the Court. 1:45 p.m. Jury enters the courtroom and is given preliminary instructions by the Court. 2:07 p.m. Government's opening statement. 2:23 p.m. Jury exits the courtroom. 2:25 p.m. Court is in recess.

2:39 p.m. Court reconvenes. Jury is present. Government's opening statement continues. 3:09 p.m. Defendant's opening statement. 3:54 p.m. Jury exits courtroom. Sidebar discussion is held. 4:06 p.m. End sidebar. Court is in recess.

4:11 p.m. Court reconvenes. Jury is not present. Discussion is held regarding Juror 15 as set forth on the record. 4:15 p.m. Jury enters the courtroom. **Government's case:** Kristy Morgan is sworn and examined. 4:28 p.m. Jury exits the courtroom. 4:33 p.m. Court is in recess and will reconvene on Wednesday, May 30, 2012 at 8:30 a.m.
