## INTRODUCTION

1  
2 Amicus curiae the Center on the Administration of Criminal Law (the “Center”)  
3 respectfully submits this brief in support of Plaintiff the United States of America’s motion for a  
4 preliminary injunction. The Center, based at New York University School of Law, is dedicated  
5 to defining and promoting good government practices in the criminal justice system through  
6 academic research, litigation, and participation in the formulation of public policy. The Center’s  
7 litigation practice aims to use the Center’s empirical research and experience to assist courts in  
8 important criminal justice cases. As the Center’s name suggests, it is devoted to improving the  
9 quality of the administration of criminal justice and advocating the adoption of best practices  
10 through its scholarly, litigation, and public policy components.  
11

12  
13 The Center’s Executive Director, Anthony S. Barkow, was a federal prosecutor for  
14 12 years and worked in two United States Attorney’s Offices—the United States Attorney’s  
15 Office for the Southern District of New York, where he prosecuted terrorism cases, and the  
16 United States Attorney’s Office for the District of Columbia—and in the United States  
17 Department of Justice in Washington, D.C. The Center’s Senior Fellow, Anne Milgram, was the  
18 Attorney General of the State of New Jersey from 2007 to 2010, where she spearheaded  
19 investigations into gang violence, public corruption, and mortgage foreclosure and debt  
20 reduction schemes. Before that, she was a prosecutor in the Manhattan District Attorney’s Office  
21 and in the United States Department of Justice’s Civil Rights Division, Criminal Section, where  
22 she prosecuted human trafficking crimes.  
23

24  
25 The Center files this amicus brief out of concern that Arizona Senate Bill 1070, as  
26 amended by Arizona House Bill 2162 (the “Arizona immigration law”), is counterproductive to  
27 good government practices in the criminal justice system and the law enforcement community  
28 overall. In particular, the Center is concerned that the law, by placing local police officers in the

1 position of acting as immigration officials, will drive a wedge between police officers and the  
2 immigrant communities they serve. The principal mission of local law enforcement officers is to  
3 enforce State, County, and local criminal laws and to protect the communities they serve. A  
4 critical component of achieving success in that mission is having the cooperation and trust of the  
5 members of those communities. Maintaining a strong, positive relationship between police  
6 officers and the community promotes public safety because individuals feel more comfortable  
7 coming forward to report suspicious activity and to cooperate with law enforcement working to  
8 solve or prosecute a crime. The Arizona immigration law threatens to undermine those  
9 relationships with a large segment of the community—in particular, immigrant members—by  
10 making them fearful that interacting with police officers will result in deportation for themselves  
11 or someone they know. Public safety and national security will suffer as police officers lose  
12 valuable information that allows them to prevent and solve crime locally and to prevent terrorist  
13 acts against our nation.

#### 16 ARGUMENT

#### 17 18 **THE ARIZONA IMMIGRATION LAW THREATENS** 19 **PUBLIC SAFETY BY UNDERMINING LAW ENFORCEMENT** 20 **EFFORTS TO MAINTAIN POSITIVE RELATIONSHIPS** 21 **AND OPEN LINES OF COMMUNICATION WITH** 22 **THE COMMUNITIES THEY SERVE**

23 The Arizona immigration law “will actually increase crime, not decrease” it. Los  
24 Angeles Police Chief Charlie Beck, quoted in *Who Do You Trust on Immigration—Police Chiefs*  
25 *or Politicians?*, AMERICA’S VOICE, May 27, 2010, [http://americasvoiceonline.org/press\\_releases/](http://americasvoiceonline.org/press_releases/entry/who_do_you_trust_on_immigration_police_chiefs_or_politicians/)  
26 [entry/who\\_do\\_you\\_trust\\_on\\_immigration\\_police\\_chiefs\\_or\\_politicians/](http://americasvoiceonline.org/press_releases/entry/who_do_you_trust_on_immigration_police_chiefs_or_politicians/) [hereinafter, “*Police*  
27 *Chiefs or Politicians*”]. The reason is simple: “[p]eople will be more hesitant to report crimes,  
28 and that will create some very, very tough circumstances for local police in dealing with crime  
issues in areas heavily visited by people here from other countries.” George Gascón, former

 7 element because they will have less reason to be concerned about being reported by victims or  
 8 witnesses in immigrant communities, and less reason to fear any consequences for criminal  
 9 conduct.” Proposed Declaration of George Gascón, dated May 28, 2010, *Friendly House, et al.*  
 10 *v. Whiting*, No. 10-cv-1061 (D. Az. filed June 14, 2010) (Dkt. No. 112) (“Gascón Decl.”) ¶ 12.  
 11  
 12 The end result is increased crime that will affect immigrant communities—indeed, communities  
 13 as a whole—due to the creation of “a vacuum in law enforcement.” *Id.*

15 **A. Law Enforcement Officials are Concerned Over the Damaging Impact the**  
 16 **Arizona Immigration Law May Have on Public Safety and Their**  
 17 **Relationship With Large Segments of the Community**

18 Over the past two decades, law enforcement officers have placed great emphasis  
 19 on a method of policing known as community policing.<sup>1</sup> Under the community policing model,  
 20 police officers look to build positive relationships with the communities they serve and, as a  
 21

1 result of those relationships, “obtain valuable information from neighbors and rely on local  
2 residents to monitor suspicious activities.” Sylvia R. Lazos Vargas, *Missouri, the “War on*  
3 *Terrorism,” and Immigrants: Legal Challenges Post 9/11*, 67 MO. L. REV. 775, 795 (2002). The  
4 underlying rationale is that, simply put, “law enforcement is more effective when police efforts  
5 are supported by the community.” *Id.*<sup>2</sup>

6  
7           Efforts to maintain public safety through community policing, however, are only  
8 effective if the *entire* community is engaged in the process, including members of the community  
9 who are immigrants. In Arizona, according to the 2000 census, over twelve percent of Arizona’s  
10 population was foreign born and over forty percent of the population was minority, including  
11 one-third of Hispanic or Latino origin. *See State & County Quick Facts*, U.S. Census Bureau,  
12 2008 Statistics, *available at* <http://quickfacts.census.gov/qfd/states>  
13 [/04000.html](http://quickfacts.census.gov/qfd/states/04000.html). In addition, the most recent statistics indicate that approximately 460,000  
14 unauthorized immigrants reside in Arizona (approximately four percent of the current state  
15 population). *See* Michael Hoefer, Nancy Rytina, & Bryan C. Baker, *Estimates of the*  
16 *Unauthorized Immigrant Population Residing in the United States: 2009*, POPULATION ESTIMATE,  
17 January 2010, *available at* <http://www.dhs.gov/xlibrary/assets/statistics/>

1 publications/ois\_ill\_pe\_2009.pdf. Local law enforcement in Arizona, therefore, simply cannot  
2 effectively maintain public safety if such large segments of the community are alienated or  
3 unwilling to interact with law enforcement out of fear of possible deportation for themselves or  
4 someone they know.

5 For these reasons, numerous law enforcement officials from across the country—  
6 including officials from areas that also experience significant patterns of legal and illegal  
7 immigration—oppose the Arizona immigration law. In particular, they are concerned with the  
8 counterproductive effects it may have on community policing and public safety:  
9

10 Effective local policing is entirely dependent upon the  
11 relationship between officers and the communities they serve.  
12 Members of the community must be able to trust the police in  
13 order to feel comfortable enough to call them when there is a  
14 problem. . . .

15 Community policing efforts during the last 20 years have  
16 helped bridge gaps in trust, especially with immigrant  
17 communities, and markedly have contributed to crime reduction.  
18 However, when victims or witnesses to crimes are afraid to call the  
19 police because of their immigration status and mandatory reporting  
20 requirements, many serious crimes will inevitably go unreported.  
21 This escalates cycles of violence and also grants tremendous power  
22 to certain unscrupulous employers in exploiting an entirely new  
23 and silent group of victims.

As Chief Roberto Villasenor of the Tucson Police Department has explained,  
“[w]hen you enact legislation that makes any subset of that community feel like they are being  
targeted specifically or have concerns about coming forward and talking to police, that damages

1 our capability to obtain information to solve the crimes.” Tim Gaynor, *Arizona police officer*

 3 320100605.<sup>3</sup> Chief Villasenor’s concerns over the damage that the Arizona immigration law  
 4 would cause to law enforcement’s ability to obtain valuable information from immigrant  
 5 communities has been echoed by numerous chiefs of police, including:

1           The deleterious effect of the Arizona immigration law is not confined to localities  
2 or immigrant communities. Indeed, it poses a risk to national security by undermining the  
3 positive relationships forged with immigrant communities and the ability of police to obtain  
4 valuable information from *all* members of the community. For example, the New York City  
5 Police Department has gone to great lengths to utilize the city’s immigrant communities,  
6 including its Muslim community. In a 2005 speech to the city’s Muslim leaders, Raymond W.  
7 Kelly, New York Police Department Commissioner, stressed to “immigrants in particular . . . that  
8 the Police Department is *not* an immigration agency.” David A. Harris, *The War on Terror, Local*  
9 *Police, and Immigration Enforcement: A Curious Tale of Police Power in Post-9/11 America*, 38  
10 *RUTGERS L.J.* 1, 45 (2006) [hereinafter *Curious Tale*] (emphasis added). Richard A. Clarke,  
11 former National Counterterrorism Coordinator for the National Security Council who advised  
12 both the Clinton and George W. Bush administrations, has similarly stressed the need to “seek  
13 the cooperation of the American Muslim community in identifying possible problem groups and  
14 individuals.” *Id.* at 47. The reason for building such relationships is that “the prime ingredient  
15 for anti-terrorism work on any level is, and will always be, information.” *Id.* at 46. As the  
16 former Chief of Operations and Analysis of the CIA Counterterrorism Center and former Special  
17 Assistant for Intelligence of the Office of the Secretary of Defense, Vincent Cannistraro, has  
18 explained, “the problem of terrorism is one of getting intelligence, having the information to  
19 preempt terrorist acts before they occur. If you don’t have good intelligence, you don’t have  
20 good antiterror.” *Id.* at 46 n.166 (quoting Cannistraro’s remarks at the 26th National Legal  
21 Conference on Immigration & Refugee Policy (Apr. 3, 2003)). Unless police officers have  
22 access to the valuable information that results from maintaining positive relationships with the  
23 community, the entire nation is at an increased risk.  
24

1           The value of this type of cooperation on the terrorism front is not theoretical. The  
2 recent arrest of accused terrorists at Kennedy Airport on June 5, 2010, was facilitated by the  
3 fathers of both suspects—one of whom is a Dominican immigrant from New Jersey. *See* Barry  
4 Paddock et al., *Father of New Jersey Terror Suspect Carlos Almonte Says He’s Not Supporting*

8 and Toledo, Ohio, that vital intelligence has been contributed by members of the Middle Eastern,  
9 Muslim and Arab communities, both of documented and undocumented status.” Jennifer M.  
10 Hansen, Comment, *Sanctuary’s Demise: The Unintended Effects of State and Local Enforcement*  
11 *of Immigration Law*, 10 SCHOLAR 289, 317 (2008) (citing David Harris, *Avoidable Disaster:*

17 prevent another terrorist attack cannot be won without the support this community gives.” *Id.*  
18 (Special Agent in Charge, Ted Wasky, of the Cleveland FBI field office, quoted in Mike  
19 Wilkinson & Christina Hall, *3 Charged in Terror Plot: Local Suspects Planned Attacks in Iraq,*  
20 *U.S. Says*, TOLEDO BLADE, Feb. 22, 2006 at A1)).

21           Past efforts to have local law enforcement officers act as immigration officials  
22 illustrate the damaging impact such efforts can have on public safety. *See, e.g.*, Orde F. Kittrie,  
23 *Federalism, Deportation, and Crime Victims Afraid to Call the Police*, 91 IOWA L. REV. 1449,  
24

1 1480 (2006) (noting that several empirical studies have found a causal link between the threat of  
2 deportation and reduced crime reporting by immigrants). For example, in Irving, Texas, a  
3 cooperative arrangement between the police department and the Bureau of Immigration and  
4 Customs Enforcement (“ICE”) led its citizens to regard the city as anti-Hispanic. *See* Huyen  
5 Pham, *Problems Facing the First Generation of Local Immigration Laws*, 36 HOFSTRA L. REV.  
6 1303, 1309 (2008) (citing Brandon Formby, *Hispanics in Irving Feeling Disheartened*, DALLAS  
7 MORNING NEWS, Oct. 7, 2007, at B1, *available at* [http://www.dallasnews.com/sharedcontent](http://www.dallasnews.com/sharedcontent/dws/news/localnews/stories/DN-irvimmigration_07met.ART.North.Edition1.424c966.html)

4           Recognizing the counterproductive effects of alienating large segments of a  
5 community, many local governments and law enforcement agencies have done the opposite of  
6 Arizona, implementing policies to encourage positive relationships and open lines of  
7 communications with immigrant communities. As of December 2008, there were at least 73  
8 cities, towns, counties and states—including Alaska, Los Angeles, San Francisco, the District of  
9 Columbia, Chicago, Baltimore, Boston, Detroit, Minneapolis, St. Paul, Montana, New Mexico,  
10 New York City, Oregon, Philadelphia, Pittsburgh, Austin, Houston, Seattle, and Milwaukee—  
11 that, at various times, implemented non-cooperation-type laws, ordinances, or other directives  
12 prohibiting or limiting the activities of local government, particularly law enforcement, in  
13 enforcing federal immigration laws to avoid alienating the immigrant communities (both legal  
14 and illegal) that they serve. *See Laws, Resolutions and Policies Instituted Across the U.S.*

15

20           Furthermore, law enforcement's deep concern over the Arizona immigration law  
21 echoes similar opposition to past Congressional efforts to pressure local governments and law  
22 enforcement agencies to enforce immigration law. In particular, in 2003, bills were introduced in  
23 both houses of Congress that, if passed, would have encouraged state and local law enforcement  
24 officials to investigate, apprehend, detain, and remove aliens in the United States, and would  
25 have limited federal funding of states that failed to expressly authorize police officers to enforce  
26 federal immigration laws. *See Harris, Curious Tale, supra*, at 26, n.103 (discussing the Clear  
27  
28

1 Law Enforcement for Criminal Alien Removal Act of 2003 (“CLEAR”) and the Homeland  
2 Security Enhancement Act). At the time, numerous law enforcement officials publicly opposed  
3 the legislation for reasons similar to the present law enforcement opposition to the Arizona  
4 immigration law. For example, Overland Park (Kansas) Police Chief John Douglass explained  
5 as follows:

6  
7 Our City and our Police Department have taken the lead in  
8 establishing a meaningful relationship with our minority  
9 communities, especially the Hispanic community. If the CLEAR  
10 Act is voted into law, it will have a devastating effect on how we  
11 provide law enforcement/police service. It will diminish the  
12 positive strides we have made to embrace minority group  
13 members. We have accomplished so much, and this proposed  
14 legislation would certainly reverse our success.

15  
16 *CLEAR Hearings* at 74 (letter from John Douglass, Overland Park Police Chief, to The  
17 Honorable Dennis Moore); *accord id.* at 143 (letter from Ronald Miller, Kansas City Police  
18 Chief, to Senator Sam Brownback). Boston Police Commissioner Paul Evans similarly  
19 explained that “[b]y turning all police officers into immigration agents, the CLEAR Act will  
20 discourage immigrants from coming forward to report crimes and suspicious activity.” *Id.* at 173  
21 (letter from Paul F. Evans, Boston Police Commissioner, to Senator Edward M. Kennedy). In the  
22 end, Evans predicted, legislation which tasked local police with immigration duties would  
23 “mak[e] our streets less safe.” *Id.*<sup>13</sup> Here, the Arizona immigration law threatens to do the same.

1           **B.       The Arizona Immigration Law Undermines Law Enforcement Efforts To**  
2           **Effectively Police The Communities They Serve**

3                       Specifically, the Arizona immigration law has two components that threaten to  
4 create a divide between local police officers and the immigrant communities in Arizona and thus  
5 impede the task of policing in Arizona. First, the law provides that “[f]or any lawful stop,  
6 detention or arrest” made “in the enforcement of any other law or ordinance of a county, city or  
7 town or this State” the local police officer “shall” make a reasonable attempt to determine the  
8 immigration status of the person if there is reasonable suspicion that the person is an alien and  
9 unlawfully present in the United States. Ariz. Rev. Stat. § 11-1051(B). Hence, whenever police  
10 officers respond to a call of suspicious activity or disorderly conduct, they must, as a matter of  
11 course, investigate the immigration status of any suspects they encounter if there is reasonable  
12 suspicion that the person is here illegally.<sup>14</sup> Second, the Arizona immigration law makes the  
13 willful failure to register or to carry an alien registration document, as required by federal  
14 immigration law, a state crime. Ariz. Rev. Stat. § 13-1509(A). In doing so, the law sends a clear  
15 message to the public that local police officers have the authority—indeed, the obligation—to  
16 investigate the status of any individual they encounter if they have reason to believe the person  
17 may not be properly registered or is not carrying proof of registration.  
18

19                       In immigrant communities, these provisions will discourage individuals from  
20 reporting suspicious activity or even a crime out of fear that doing so may trigger an immigration  
21

22  
23

28 forward to report crimes and suspicious activity.”) (quoting Newark Police Chief Ray Samuels).

1 status inquiry into themselves or someone they know. Even if they recognize that an  
2 undocumented alien is committing a crime, individuals in these communities may, nevertheless,  
3 view a deportation “as too harsh [a punishment] to make calls [to the police] that might involve  
4 inquiries into [the] suspect’s immigration status.” Vargas, *supra*, at 795. In addition, even if they  
5 are here legally, individuals are not likely to come forward if an incident involves a loved one  
6 who is not. See Pham, *supra*, at 1399 (explaining that because many immigrant families are of  
7 “mixed status” where certain children may be citizens but older siblings or parents may not,  
8 family members may refrain from contacting police to avoid drawing attention to family  
9 members without legal status); see also Proposed Declaration of Eduardo Gonzalez, dated May  
10 28, 2010, *Friendly House, et al. v. Whiting*, No. 10-cv-1061 (D. Az. filed June 14, 2010) (Dkt.  
11 No. 114) (“Gonzalez Decl.”) ¶ 13 (“This distrust of law enforcement will be created whether or  
12 not community members have legal status, both because immigrant families and communities  
13 are typically made up of both those with lawful status and those without . . . .”) (former Chief of  
14 Tampa Police Department and former Director of United States Marshals Service). These fears  
15 are likely to be magnified by the law’s failure to provide a safe harbor for crime victims or  
16 witnesses—*i.e.*, the law “does not provide any assurances to those who assist law enforcement in  
17 ongoing investigations that their legal status will not be investigated at a future date after the  
18 criminal investigation is concluded.” Granato Decl. ¶ 12.

19  
20  
21  
22           These problems are compounded by the wording of the Arizona immigration law,  
23 which fails to provide officers, and the individuals they protect, with sufficient guidance as to  
24 how to enforce and obey, respectively, the law. This will unfairly burden the police. At the same  
25 time, it will undoubtedly contribute to the hesitation of an uncertain immigrant community to  
26 interact with law enforcement.  
27  
28

1           In particular, by its own terms, the Arizona immigration law targets “unlawfully  
2 present aliens.” Ariz. Rev. Stat. § 11-1051. However, although the law instructs police officers  
3 to ignore race, color or nationality when attempting to enforce it, it fails to provide officers—  
4 and, equally important, the communities they serve—with guidance as to what constitutes a  
5 reasonable suspicion that someone is here illegally, short of an inquiry to the appropriate federal  
6 authorities and a potential detention while that is done. This uncertainty leaves the indelible  
7 impression that the law will ensnare, and allow for the detainment of, individuals in Arizona who  
8 appear to be immigrants and who are stopped for relatively minor offenses (including, for  
9 example, traffic offenses). Furthermore, given that Hispanics comprise over one-third of the  
10 state’s population, *see supra* at 6, this uncertainty has the potential to adversely and  
11 disproportionately impact a large segment of the state population.  
12

13           The rationale that the Supreme Court of the United States has announced for  
14 applying the void-for-vagueness doctrine is instructive when analyzing the difficulties that the  
15 Arizona law presents. Specifically, in a string of cases spanning the last forty years, the Supreme  
16 Court has repeatedly invalidated laws as impermissibly vague where police officers are asked to  
17 detain various classes of persons—*e.g.*, vagrants, loiterers, persons who fail to carry “credible”  
18 identification, and persons hanging around with gang members for no “apparent purpose”—  
19 where neither the officers nor the community are provided with sufficient guidance as to how an  
20 officer might determine that a person is in the offending class. *See, e.g., Kolender v. Lawson*,  
21 461 U.S. 352, 361 (1983) (“Although the initial detention is justified, the State fails to establish  
22 standards by which the officers may determine whether the suspect has complied with the  
23 subsequent identification requirement.”); *see also City of Chicago v. Morales*, 527 U.S. 41, 58-  
24 59 (1999); *Papachistou v. City of Jacksonville*, 405 U.S. 156, 166 (1972); *Coates v. City of*  
25  
26  
27  
28

1 *Cincinnati*, 402 U.S. 611, 614 (1971). The Arizona immigration law suffers from similar defects.  
2 *See* Gonzalez Decl. ¶ 16 (“SB 1070 does not give sufficient tools to allow police officers to  
3 enforce its provisions without coming into conflict with established constitutional protections,  
4 such as the protection against unlawful detention and racial profiling. . . . The simple fact is that  
5 there are no sound ways for police officers to tell whether someone has lawful immigration status  
6 simply by observation.”); Gascón Decl. ¶ 18 (“Short of directly observing an individual actually  
7 crossing the border in a surreptitious way, there are not reliable indicia that would give rise to a  
8 reasonable suspicion to believe that a person is unlawfully in the United States.”).

9  
10           Furthermore, the fact that an inquiry into immigration status may only occur  
11 during the enforcement “of any other law or ordinance of a county, city or town or this state,”  
12 does little to alleviate the dilemma given the breadth of the category of offenses covered, which  
13 would appear to include petty disorderly persons offenses (such as loitering) and minor traffic  
14 infractions. For example, what would otherwise have been a relatively brief detention during a  
15 traffic stop has the potential to become much lengthier as the officer tries to determine the  
16 immigration status of a driver who could be perceived to be an immigrant. This lack of clarity in  
17 the law, therefore, has the potential to further alienate large segments of the population in  
18 Arizona, and in the process undermining public safety.

19  
20           Indeed, the mere *perception* that the Arizona law unfairly targets individuals who  
21 appear to be immigrants may create a divide between the immigrant population and law  
22 enforcement. Recent empirical data demonstrates that an immigrant population that perceives  
23 laws or police policies to be illegitimate or unfair will be less likely to assist law enforcement  
24 (including interacting with police or volunteering information). *See* Tom R. Tyler, et al.,  
25 *Policing Against Terrorism: Legitimacy and Deterrence Strategies for Motivating Cooperation*

### 11 **CONCLUSION**

12  
13 Arizona law enforcement officials should not be burdened with a statute that will  
14 hamper efforts to engage in effective community policy by alienating a substantial minority  
15 population. Public safety will suffer if large segments of a community are alienated and fearful  
16 of interacting with police officers. Accordingly, because of the harm the Arizona immigration  
17 law may cause to public safety, the Center respectfully submits that the United States’ motion for  
18 a preliminary injunction should be granted.
