Dear Sir,

This letter is in response to two complaints filed against us, Joseph J. Lipari and Eileen H. Lipari which was served upon us September 14, 2010. In accordance to the rule for a 21-day response, we are answering the complaints in the only way we can. We have no resources or funds to hire an attorney and have been searching for over 2 ½ weeks for someone to help us "pro bono". Unfortunately, we have been unsuccessful. We have nothing of value left to sell. And this letter is our only opportunity to respond to the complaints in a timely manner. We are not lawyers, and beg your indulgence while we answer the complaints.

That being said, we DENY the allegations of the monies claimed owed made in the Complaint. We have not resided in Arizona since November 2007 and question whether the Court has jurisdiction over us in this matter.

By way of explanation, we hired Mr. Jimmy C. Chisum to put the property in question into a trust; the beneficiary of which was to be a scholarship fund for an educational institution. That was done on May 14, 1992 and after that date we no longer had any right or interest in that property. We still don't and never will.

Joseph J. Lipari is permanently disabled following complications from open-heart surgery which took place in January 2008. Additionally he is current undergoing bouts with severe depression.

Eileen H. Lipari is wheel-chair bound with Muscular Dystrophy and currently is in renal insufficiency with skeletal degeneration. The day following service of the Complaint, she was admitted to an Emergency Room under suicide watch.


Neither Joseph J. Lipari nor Eileen H. Lipari can travel to Arizona for this action. A 1985 pick-up truck in need of tires and mechanical repair makes traveling that distance, with the expense and time involved, impossible under the current circumstances and medical monitoring required.


There has NEVER been a belief that we could avoid paying taxes and have filed each and every return, in cooperation with the Internal Revenue Service, agents Paul Chase and Debbie Vahe. Some were audited and approved by Cheryl Bradley and resulted in lower amounts owed than those shown in the Complaint. To claim that we owe these higher amounts simply isn't right or fair. Because of our economic situation and disabilities, there will never be any way we can pay any amount, and still provide for our basic necessary needs.

We know this isn't in the proper format for a response, but it's all we have left to do. We have no choice and apologize to the Court in advance for our shortcomings. We pray that the Court understands and will not force us to pay anything or hold us responsible for any court costs, as we simply cannot afford to pay anything.

If this response is inadequate for the Court, please give us additional time to provide what you require, Thank you.
