14 to the requested relief, and good cause appearing,

15 **IT IS ORDERED:**

16 1. John Friedeman may appear “specially” as attorney of record for Exeter Trinity
17 Properties, LLC. Mr. Friedeman, at his own request, shall not participate in discovery, shall
18 not file dispositive motions and shall not participate in pre-trial procedures nor in trial.

19 2. In the event the Plaintiff and Exeter Trinity Properties, LLC, are not able to enter
20 into a settlement within 60 days, Mr. Friedeman may withdraw as attorney of record for
21 Exeter Trinity Properties, LLC, by filing a Notice of Withdrawal, and referencing this Order.
22 His withdrawal shall be effective upon filing the Notice.

23 3. In the event Exeter proves unable to raise the funds to pay a stipulated settlement
24 amount and the Plaintiff files the stipulated judgment, then Mr. Friedeman may withdraw as
25 attorney of record for Exeter Trinity Properties, LLC, by filing a Notice of Withdrawal, and
26 referencing this Order. His withdrawal shall be effective upon filing the Notice.
