(Oral Argument Requested)


18 Defendants move this Court for a 180-day extension of time for Defendants to
 19 respond to Plaintiff's Motion for Summary Judgment dated May 11, 2012, from the
 20 current deadline of June 21, 2012, to and including December 21, 2012. Defendants'
 21 counsel, Tommy K. Cryer, tragically died unexpectedly on June 4, 2012. Defendants
 22 require additional time to retain a competent replacement lawyer to represent Defendants
 23 in this matter. Further, Defendants have not yet received their file from the office of their
 24 deceased attorney. Once found and retained, Defendants' new attorney will require this
 25 additional time to become familiar with Defendants' file, as well as time to review and
 26 analyze the 4,000 pages of documents submitted by Plaintiff in response to Defendants'
 27 First and Second Set of Interrogatories and Requests for Production of Documents dated
 28 1/03/2012 and 1/04/2012, respectively.


1 For the above reasons, Defendants are seeking a 180-day extension of time to file

4 This Motion is not made for the purpose of delay.


