Trial Notes of Terry I. Major

PREFACE:

These notes are rather rough. It is a lot to follow and I did the best I could. The volume, at times, made it a bit difficult to hear. At least the notes will give the reader and opportunity to get an overview of what went on in the court.

I was not able to attend on Thursday, March 22nd. The notes, so far, are for Tuesday and Wednesday (March 20th and 21st). This was the first two days of trial. I will attempt to not miss any other days.

March 20, 2018: Day 1

The first day of trial was devoted primarily to Jury selection. The jury pool began with sixty-seven (67) potential jurors. It was a very interesting process. The judge began first by asking a series of questions and after receiving responses from the various potential jurors, the attorneys also were given the opportunity to ask questions as well. When this process was complete, the court and attorneys came up with the final list.

After a break while the selection process was finalized, the court resumed and the selected jurors were identified and seated. The others were dismissed. Fifteen (15) jurors were selected. Three (3) of the jurors are alternates, but they will not be identified until just before deliberations. In this way, it is believed, all of the jurors will pay close attention to the presentations.

- 5. Three customers were undercover agents: Sergei, Tom and Jake.
- 6. In late 2014, the IRS began an undercover operation.
- $7. \ \ Local bit coins. com-advertise: Morpheus\ Titania.$
- 8. Ad stated he would take up to a \$50,000.00 amount.
- 9. Mycelium App sender to receiver encrypt.

- 10. Mycelium sends in broken parts for security.
- 11. Listed info: Who's Morpheus
- 12. Advertise Anonymity.
- 13.2016/2017 30K =sale of 1K Cocaine
- 14. Telegram app for communications
- 15.107K transaction amount
- 16. Sting Nolan 18 yr old started trading drugs.
- 17. Buy Bitcoin on Coinbase
- 18. Morpheus sold 40K BC to Nolan
- 19. Why not report case of money laundering.

March 21, 2018: Day 2

The second day of trial began with the Defense making their opening statement:

The following points were made:

- 1. There was a plan to entrap Thomas by the IRS.
- 2. The IRS did not have a specific knowledge that Thomas was doing anything illegal.
- 3. You will hear that the undercover agents met with him and traded for Bitcoin.
- 4. They began with \$2,000.00, then \$3,000.00 and worked their way to higher amounts.
- 5. Drugs were not mentioned at the first meeting.
- 6. A witness for the Prosecution will be Nolan Sperling.
 - a. Mr. Sperling was an importer of drugs from Mexico.
 - b. He did not tell Thomas of his business.
 - c. He has been offered a special "deal" for his testimony.
 - d. You, as the jury, must evaluate the importance of such testimony.
- 7. How did the agents deal with Thomas?
- 8. The Government relies on Mr. Sperling.
- 9. What did Thomas intend?
- 10. Avoidance of the Reporting Requirement? Motivated by Bitcoin!
- 11. Thomas simply charged a fee to do the exchange.

First Witness: Michael Fleischmann

- 1. Michael is a Special Agent for the IRS Criminal Investigation Division.
- 2. His experience is in the investigation of Financial Crimes.
- 3. He was initially an IRS Agent.
- 4. College: University of Arizona Accounting and Finance.
- 5. In 2001, he was a revenue agent.
- 6. In 2005, he became a Special Agent.
- 7. He was a CPA with 2 years of experience.
- 8. He attended a 26 week course in Georgia.
- 9. In 2015, assigned to the Washington, D.C. office worked out of Mesa, AZ.
- 10. Worked in the Cyber unit (virtual currency).
- 11. Studied the unregulated currency: Bitcoin.
- 12. It is harder to sieze unregulated currency, such as Bitcoin.

- 13. Two ways to buy virtual currency: Commercial Exchange or Peer-to-Peer.
 - a. Coinbase: must provide personal identification.
 - b. Pay through bank transfer or credit card.
 - c. Exchange Rates: 1 to 1.5%.

 - b. Transaction fees: 7 to 10%.

 - d. A new wallet can be used for each transfer (more security).
- 16. Blockchain is a public ledger: commission of transfer and miner fees.
- 17. Notes on Peer-to-Peer transactions:
 - a. It is easy to sell illegal products using virtual currency.
 - b. How does one get money from these sales into Bitcoin?
 - c. Ads on http://localbitcoins.com/.
- 18. The localbitcoins.com website was used to identify Thomas'.
- 19. The one individual with the most positive feedback was Morpheus.

- 20. This exhibit profiles Morpheus on the web.
- 21. From this document, with a little research and investigation, the name of Thomas Costanzo was determined.
- 22. Page 1 of the document stated the trade limits for Morpheus: \$15,000.00 up to \$50,000.00.
- 23. A federal form must be filed for any transaction of \$10,000.00 or more.
- 24. Based on Thomas' profile, the number of trades he had done, the high volume, the positive feedback, it was decided to focus on Thomas.
- 25. Page 2 of the document stated the preferred meeting places were Starbuck's of McDonalds.
- 26. The Ad states that Morpheus would travel all over the Valley and gave a phone number.
- 27. It also stated that he loved to meet with "newbies".

- 28. Morpheus loves to talk.
- 29. He uses Mycelium for security.

Exhibit 76: Biography of Morpheus

- 30. Page 3 of document:
 - a. The Bio states that he is willing to conduct 3rd party exchanges.
 - b. It also provides background information and named his x-wife.
 - c. This gave needed information to identify Morpheus.
- 31. This provided the material needed to allow the written limited undercover request.
- 32. The first test trade took place on March 15, 2015:
 - a. Sergei met with Morpheus and conducted a trade of \$2,000.00 for Bitcoin.
 - b. This meeting was recorded.
- 33. The second test trade took place on May 20, 2015:
 - a. This trade was for \$3,000.00 in exchange for Bitcoin.
 - b. This meeting was recorded.
- 34. The third test trade took place on October 7, 2015:
- 35. The fourth test trade took place on November 21, 2015:
- 36. The final trade took place on April 20, 2017:

CROSS EXAMINE:

- 1. To reiterate: 17 years' experience with the IRS.
- 2. Became Special Agent in 2014.
- 3. Studied Virtual Currency in 2014
- 4. Worked in Cyber Crime Investigations 2015.
- 5. Study Blockchain open and transparent but difficult to analyze.
- 6. The Blockchain is not anonymous, but is pseudo-anonymous.
- 7. There is high volume on the commercial exchanges.
- 8. Examples: Bitstamp, Mt. Gox, Bitfloor had data breaches.
- 9. Similar to Equifax.
- 10. Thus, some people prefer the Peer-to-Peer for the security of the Bitcoin purchases and holding rather than a commercial exchange.
- 11. http://www.yelp.com/ is a website where you can review various services, including those businesses that accept Bitcoin.
- 12. In December of 2014 wondered if Morpheus would accept trading Bitcoin for large amounts.

Exhibit 75: revisit this exhibit.

- 13. Morpheus advertisement stated he would do exchanges of \$15,000.00.
- 14. He was also willing to do small exchanges of \$20.00 to \$1,500.00 and \$7,000.00 to \$15,000.00.

Exhibit 76: Explains the moniker – "Morpheus"

- 15. Agent has never seen the movie "The Matrix".
- 16. Requirements and goals for investing:
 - a. Identify the Customer.
 - b. Determine if the amount is over \$10,000.00.
 - c. Determine source of funds if unlawful activity: drugs?
 - d. There is a LONG list of SUA's (suspicious activities).
 - e. Meetings were scheduled with Morpheus to determine if he would do business even if the amount and source were problematic.
 - f. Rapport was established with Morpheus a trust relationship was formed.
 - g. Actual Cash was used for the transactions.
 - h. The ruse was that the funds did not come from drug sales.
 - i. Audio recordings were made at the various meetings with Morpheus.

After the jury left the room, a conference was held between attorneys and the judge:

- 17. Prosecution was prohibited from bringing up the "Dark Web" and people using Bitcoin for the purchase of drugs.
- 18. Defense expects to produce information on Bitcoin, Commercial activity and Peer-to-Peer.

After break: Prosecution Redirect:

- 19. Agent states he has never seen "The Matrix".
- 20. Agent began with IRS in 2001.
- 21. Cases worked:
 - a. Virtual Currency Cases 4 years.
 - b. Money Laundering 13 years.
- 22. To avoid problems with a "hacked" exchange one may keep their virtual currency on a "paper wallet".
- 23. There are two keys: Public and Private.
- 24. How was Morpheus determined to be Thomas explained.
- 25. Who chose drugs for the SUA (Suspicious activity) and why explained.

Second Witness: Sergai Kushner

- 26. Has been an agent with the IRS for 20 years.
- 27. Began as a Revenue Agent in the civil division.
- 28. Was eventually moved as a Revenue Officer to Collections.
- 29. IN 1998 was trained in Georgia as a Special Agent.
- 30. Specialize in Computer internet ... unit.
- 31. Went undercover in 2007.
- 32. He is a natural born Russian, thus his accent.
- 33. Worked out of Washington, D.C. office assigned to New York then Arizona.
- 34. In 2015 he contacted Morpheus to set up a transaction for Bitcoin.
- 35. Research showed Morpheus to be Thomas Costanzo.
- 36. Since Sergai is Russian, he fir the role as an import/export business owner.
- 37. He met with Morpheus to set up rapport.
- 38. He met with Moprheus to see if he would do a trade after being told the funds came from heroin sales.
- 39. They based their selection of Morpheus from his "local bitcoins" we advertisement.

Reference Exhibit 75: Page from the localbitcoins.com website.

- 40. Used the information from the Ad to contact Morpheus by Phone.
- 41. Text messages were preserved and downloaded.

Exhibit 70: Forensic Report of Text Messages

- a. 5 pages of messages listed in reverse order.
- b. Included is a summary of technical information.
- 42. Sergai contacted Morpheus on January 27, 2015 from New York and asked if he would be willing to sell \$3,000.00 of Bitcoin by wire transfer of funds.
- 43. Morpheus declined.
- 44. On March 15, 2015 a meeting was held with Morpheus:
 - a. Held at Starbuck's in Chandler
 - b. Meeting was recorded.
 - c. The meeting was transcribed
 - d. Recording was played in the courtroom (The recording is of very poor quality).

- e. During the meeting Sergai told Morpheus he was in the Import/Export Business (which was his cover for this project).
- f. \$2,000.00 in Bitcoin was purchased that day by Sergai from Morpheus.

 - a. Morpheus was told Sergai could not meet with him, but his business partner would handle the meeting.
 - b. The agent's name was "Tom".
 - c. Reference Exhibit 70.
- 48. The next meeting was set for November 21, 2015:
 - a. This was a "meet-up" held at the Oasis Café.
 - b. It was audio recorded.
 - c. There were others present to obtain information about Bitcoin.
 - d. Peter Steinmetz name came up at the Meeting.
- 49. A meeting was set with Peter Steinmetz to purchase \$20,000.00 in Bitcoin.
 - a. The meeting was to take place at Peter's home in Tempe.
 - b. He was told at the meeting that the funds were from the sale of drugs.
 - c. Peter refused to enter into the transaction.

During this cross examination the following information was provided:

- a. The first meeting was March 20, 2015 at Starbucks.
- b. Due Diligence was used prior to the first meeting in review of the localbitcoins.com website.
- c. Admitted that there was nothing in the local webpage that invited drug dealers to do business with Morpheus.
- d. When meeting with Morpheus it was noted that he did not dress in a "flashy" manner nor drive a "flashy" vehicle, etc.
- e. The website boasted things that appearances did not support.
- f. There had been text communications before the first meetings.
- g. No indication was given to indicate illegal activity was involved.
- h. The March meeting was only held to complete a simple transaction.
- i. The next meeting of May 20, 2015 was for \$3,000.00.
- j. This is where heroin was introduced as the source of the funds, but this information was provided after the trade had been set to take place.
- k. Next meeting was with Tom in October of 2015.
- 1. This was to be for \$10,000.00, but a larger amount was suggested.
- m. Morpheus could not come up with it, but \$11,700.00 was traded.
- n. Morpheus stated that he had never done over \$20,000.00.
- o. Morpheus was enthusiastic about Bitcoin.
- p. He offered to show his Podcast to friends.
- q. He attended meet-ups to tout Bitcoin.
- r. He wanted to have a booth at the Home and Garden Show to explain Bitcoin.
- s. With many years as an agent the objective was a "money laundering investigation".
- t. Obective to see if Thomas would respond in a certain way.
- u. The case was built upon what Thomas said.
- v. Information of "customers" no names, TIN, other information gathered.

REDIRECT:

The redirect consisted of reiterating that Morpheus' ads did not invite drug dealers per-se, but did reference discretion, alias use and large amounts for transactions. The agent would have provided identification information, if asked. He was also told that the "Banker" could "do" larger amounts.

- d. Morpheus was able to accommodate \$13,000.00.
- e. The agents then surveilled Morpheus to see where he went for more Bitcoin.
