ORDER

This matter is before the Court on the parties’ Unopposed Motion to Continue Defendant’s Detention Hearing (Doc. 52). In the motion, Defense counsel requests that the detention hearing currently set December 19, 2023, be continued and that the deadline to file pre-hearing memorandum also be continued (*Id.*).

Defense counsel requests to continue the detention hearing stating that:

Sowerby files this motion because counsel has contemporaneously filed a motion to withdraw, and new counsel will need additional time to prepare for the hearing and confer with the government in advance to discuss potential alternatives. In addition, Sowerby was indicted in another matter (CR-23-1586-PHX-SMB) on November 14, 2023, and is moving to continue the detention hearing in that matter, which is set for the same date and time as this case. Last, counsel understands that the government may bring additional charges against Sowerby this month, which could impact the pending detention hearings and require consolidating the hearings in what will then be three matters.

(*Id.*). The Court addressed Defendant’s motion to withdraw as counsel of record by separate order.

1 The Bail Reform Act calls for a prompt detention hearing. The detention hearing
2 proceeded for over an hour on November 2, 2023, and was set to continue on November
3 28, 2023, in order to allow additional time for presentation of additional information if and
4 as the parties decide (Doc. 42). Thereafter, the Court granted the request for an additional
5 continuance to December 19, 2023 (Docs. 49, 50).

6 The arrest in this matter of Defendant Sowerby was on September 22, 2023. Based
7 on the information before the Court, the Court will vacate the deadline for additional pre-
8 hearing memoranda, but will affirm the detention hearing setting. A recording of the
9 November 2, 2023, detention hearing or a transcript thereof is available per the Court's
10 usual policies/procedures.

11 Accordingly,


12 **IT IS ORDERED** granting in part and denying in part the parties' Unopposed

16 **IT IS FURTHER ORDERED** affirming the detention hearing currently set
17 **December 19, 2023, at 9:30 a.m.** before Judge Fine in courtroom 303.

19 ____.
