John Stuart, the man, has all rights
Whereas John Stuart RPTI / RPI is

falsely detained and not able to conduct
research appropriate to this case he
hereby demands, as required under Arizona
law and the Arizona and National Constitutions,
that his detainers and/or THE STATE OF ARIZONA
supply to him forthwith the following;

- 1) A certified copy of the following documents:
 - i) BID BOND; and
 - ii) PAYMENT BOND; and
 - iii) PERFORMANCE BOND; and
 - iv) Any and all other such BOND(s); and
- 2) List of the current "HOLDER IN DUE COURSE"
of the note for each BOND; and
- 3) Complete list of all "BIDDERS" for said BOND(s);
- 4) Certified document stating actual current
location of said BOND(s);

- 5) Exact amount of each BOND; and
- 6) Certified, and signed under penalty of perjury, document stating and validating
 - i) what manner and type of funds were used to pay for said BOND(s); and
 - ii) how said funds were transferred between parties; and
 - iii) any and all parties transferring said funds had lawful and legal authority to act in such manner; and
- 7) Any and all evidence proving the chain of custody of said BOND(s) was never breached and/or violated; and
- 8) Complete, and certified, copy of original contract concerning the sale and/or transfer of said "note(s)" for said BOND(s); and
- 9) All Tax and Income Reporting documents filed for said BOND(s), and if not filed, supporting documentation signed by proper authority under penalty of perjury stating claim why said tax related documents were not filed; and
- 10) Certified Copy of Prosecutor Charbel's Oath of Office; and
- 11) Certified Copy of Prosecutor Charbel's Surety Bond, including without limitation, BOND number and amount, name, address and phone number of underwriter and/or insurer; and

of 3 12) Documentation signed under penalty of Perjury by Charbelis supervisor verifying Charbelis Oath and Bond are valid.

If this court refuses to supply ANY of the requested documents the court must consider said refusal prima facie evidence of Charbelis conspiring with the court to maliciously, with malice aforethought and acting under color of law, to falsely detain and unlawfully prosecute John Stuart, a man the court officers and Charbelis know to be innocent. Precedent sets the financial damage owed to Defendant for such acts at between \$1,700,000 to \$1,800,000 per day, not inclusive of other punitive damages caused by Charbelis and to be paid by her BOND. Thus, this court must immediately dismiss with prejudice this unlawful charge and release John Stuart, the man, from custody forthwith. This requires the court to release John Stuart, the man, from this court room WITHOUT further detention for the release process.
