THOMAS, an Attorney, is hereby authorized to use the private exemption of **John Stuart**, i.e. JOHN STUART, 526514960, for the adjustment and set-off of this instant matter, Case No.: CR-2008-006332-001DT, which is Accepted For Value, and Returned for Settlement. Fiduciary Debtor is to issue the appropriate IRS 1099 OID forms and to be in compliance with all revenue requirements in this matter timely. John Stuart reserves the right to audit all records and activities of Fiduciary Debtor to maintain good faith.

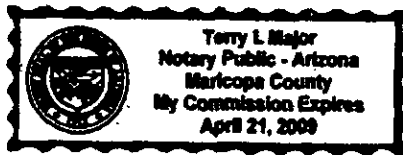
